

23. (Fish Canyon Lease No. 1024.) Upon motion duly made and unan-  
imously carried, a resolution was adopted wherein approval was given  
to the assignment of Fish Canyon Lease now held by J. C. and Margaret  
Thompson, to Thomas Nobel. Assignment to be in accordance with the  
provisions of the lease. Such assignment is not to relieve the orig-  
inal Lessees of their liability under said lease.

24. (Fish Canyon Lease No. 1045.) Upon motion duly made and unani-  
mously carried, a resolution was adopted wherein approval was given  
to the assignment of Fish Canyon Lease now held by Dr. Aletha Rhodes  
McCormick to Bernice D. King. Assignment to be in accordance with  
the provisions of the lease. Such assignment is not to relieve the  
original Lessee of her liability under said lease.

25. (Grazing Lease Applications.) The Executive Officer reported  
that three applications have been received from present lessees of  
grazing lands whose leases expired in June, July and August, 1943  
wherein they have offered to pay the minimum rental of 20 cents  
per acre per year as set by the Commission, but which offer is not  
five per cent of the value used by the County Assessor. It was  
further pointed out that these applicants have deposited with the  
Commission the amount of money necessary to advertise for bid for  
lease of land. After a discussion, a motion was duly made and unan-  
imously carried, authorizing the Executive Officer to advertise the  
lands for lease and to report back to the Commission the bids which  
might be received in order that the Commission might accept or re-  
ject any or all of such bids.

26. (Lease Application No. 106, P.R.C.) Upon motion duly made and  
unanimously carried, a resolution was adopted approving a lease to  
Mr. Ralph I. Hodshire, of Ark Site No. 11 at Corte Madera, for a  
term of five years at an annual rental of \$42.00.

27. (Cancellation of Grazing Lease No. 777, Jacob F. Derner, et al.)  
Upon being informed that Lessee Jacob F. Derner, et al. under this  
lease had failed to pay the annual rental within the statutory fif-  
teen day period and that Attorney General's Opinion No. NS 4741 re-  
quires cancellation of this grazing lease covering 640 acres in Modoc  
County, motion was duly made and unanimously carried, ordering can-  
cellation of this lease.

28. (Lease No. 22, P.R.C.) Upon motion duly made and unanimously  
carried, a resolution was adopted, confirming the assignment, under  
the terms of Corte Madera Lease No. 22, from T. C. Johnston to Sam  
Rosenberg. Such assignment is not to relieve the original Lessee  
of his liability under said lease.

29. (Special Lease No. 16 - 675 P. C.) Upon motion duly made and  
unanimously carried, a resolution was adopted giving consent to the  
Port San Luis Transportation Company for continued use of the marine  
railway easement upon the condition that they assume all obligations  
of the easement which were transferred to them under agreement dated  
October 31, 1941, by the Pacific Coast Railway.
