

12. (Application to Purchase School Land - Caroline B. Payne - Location 3132 - Independence Land District) Upon motion duly made and unanimously carried, a resolution was adopted approving the sale of Section 36, T. 32 S., R. 43 E., consisting of 640 acres in San Bernardino County to Mrs. Caroline B. Payne at the price of \$640.00. Such sale to be subject to mineral reservation to the State and approval of procedure by the Attorney General.

13. (Grazing Lease No. 1123, Agnes L. Halberstadt)-Upon motion duly made and unanimously carried, a resolution was adopted approving the issuance of a five year grazing lease to Agnes L. Halberstadt on the  $W\frac{1}{2}$  of  $SW\frac{1}{4}$ ,  $NE\frac{1}{4}$  and  $E\frac{1}{2}$  of  $SE\frac{1}{4}$  of Section 36, T. 19 S., R. 12 E., M.D.M., containing 320 acres in Fresno County at an annual rental of twenty-one cents per acre per year, provided the Lessee shall pay the first and last years' rental at the time of execution of the lease.

14. (Grazing Lease No. 1124, James C. Fuquay) - Upon motion duly made and unanimously carried, a resolution was adopted approving the issuance of a five year grazing lease to James C. Fuquay on the  $NW\frac{1}{4}$  of  $NW\frac{1}{4}$ ,  $NE\frac{1}{4}$  of  $NE\frac{1}{4}$  and Lots 1 and 4, Section 16, T. 18 S., R. 7 E., S.B.M., containing 127.68 acres in San Diego County at an annual rental of twenty cents per acre per year, provided the Lessee shall pay the first and last years' rental at the time of execution of the lease.

15. (Grazing Lease No. 1125, M. J. Lovett) - Upon motion duly made and unanimously carried, a resolution was adopted approving the issuance of a five year grazing lease to M. J. Lovett on Section 16, T. 30 S., R. 34 E., M.D.M., containing 640 acres in Kern County at an annual rental of twenty cents per acre per year, provided the Lessee shall pay the first and last years' rental at the time of execution of the lease.

16. (Grazing Lease Application 1126, Harnish Brothers Ranching Company) - Upon motion duly made and unanimously carried, a resolution was adopted approving the issuance of a five year grazing lease to Harnish Brothers Ranching Company on the  $W\frac{1}{2}$  of  $SE\frac{1}{4}$  of Section 23, T. 21 S., R. 14 E., M.D.M., containing 80 acres in Fresno County at an annual rental of twenty-five cents per acre per year, provided the Lessee shall pay the first and last years' rental at the time of execution of the lease.

17. (Federal Patent for Section 16, T. 6 N., R. 12 E., S.B.M., San Bernardino County) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Executive Officer to make application for patent from the United States for this School Land.
