

5. (Application No. 146, P.R.C. - Federal Government to lease School Lands in San Bernardino County for Aerial Gunnery Range "B") Upon motion duly made and unanimously carried, the Executive Officer was authorized to lease to the Navy 11,386.56 acres of vacant School land in San Bernardino County at an annual rental of \$242.00. The land is to be used as an aerial gunnery range by the Majave Marine Air Corps Station. The lease is to be for a one year term, with annual renewal privilege at the option of the Navy, but in no event to extend beyond six months after the date of termination of the unlimited National Emergency.

6. (Cancellation of Mineral Leases Nos. 420, 421, 422 and 423) Upon motion duly made and unanimously carried, the Executive Officer was authorized to cancel, as of June 9, 1944, Mineral Leases Nos. 420, 421, 422 and 423. The leases are in default and no response has been received from the Lessees during the thirty day period beyond the date when the Lessees were given notice of default.

7. (Lease No. 1134, P.R.C. Fish Canyon Recreational Lease) Upon motion duly made and unanimously carried, a resolution was adopted approving the issuance of a ten year recreational lease, at an annual rental of \$30.00, to Mr. Howard E. and Corabelle Clark on Lot No. 3, Fish Canyon. The lease is to be issued as of January 1, 1944, subject to the payment of the first and last annual rental at the time of execution of the Lease.

8. (Lease No. 1135, P.R.C. Fish Canyon Recreational Lease) Upon motion duly made and unanimously carried, a resolution was adopted approving the issuance of a ten year recreational lease, at an annual rental of \$30.00, to Mr. Leonard F. Swaffield on Lot No. 34, Fish Canyon. The lease is to be issued as of June 14, 1944, subject to the payment of the first and last annual rental at the time of execution of the Lease.

9. (Application to Purchase Vacant School Land - Section 36, T. 9 S., R. 19 E., M.D.M.) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the advertisement for the sale for cash of 640 acres of School land in Section 36, T. 9 S., R. 19 E., M.D.M., to the highest bidder. The advertisement shall stipulate that no bids will be accepted for less than \$10.00 per acre. *NOBLE p 523*

10. (Application to Purchase Vacant School Land, Lots 1, 2, 6, 7, and 8 of Section 8, and the NE $\frac{1}{4}$ of NE $\frac{1}{4}$ of Section 17, T. 10 N., R. 3 W., M.D.M.) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the advertisement for the sale for cash of 288.06 acres of School land in Sections 8 and 17, T. 10 N., R. 3 W., M.D.M., in Yolo County, to the highest bidder. The advertisement shall stipulate that no bids will be accepted for less than \$5.50 per acre. *SCHWAB p 539*
