

6. (State Oil and Gas Lease No. P.R.C. 145) Upon motion duly made and unanimously carried, a resolution was adopted confirming the approval heretofore given by the Executive Officer to the Beloil Corporation, Ltd., the Lido Petroleum Company and the O. C. Field Gasoline Corporation, for an additional thirty days beyond August 17, 1944, of the time limitation within which they are to acquire leases, easements or rights-of-way necessary for surface locations in accordance with the terms and provisions of Lease No. P.R.C. 145 as amended by letter agreement of June 26, 1944 and approved qualified letter of Lessee's acceptance of Lease No. P.R.C. 145 dated July 3, 1944. These extensions were granted with the understanding that the Lessees contemplate ability to procure necessary easements and/or rights-of-way for surface facilities within this thirty day period in order to commence the drilling of the first well required under the Lease.

7. (State Oil and Gas Easement No. 275) Upon motion duly made and unanimously carried, a resolution was adopted whereby approval was given for the redrilling of Wells Nos. 19 and 33 on Easement No. 275 at Kuntington Beach, and the execution of the mutual consent endorsement form covering a twenty percent royalty on future production from these two wells. Said wells are to be redrilled in accordance with the rules and regulations, which include the filing of liability bonds.

8. (Agreement No. 415 - Standard Oil Company) Upon motion duly made and unanimously carried, a resolution was adopted confirming the approval heretofore given by the Executive Officer for the 42nd, 43d and 44th revisions of the State's participating interest in the productive area of the Rio Vista Field. Under these revisions, the State's participating interest became 10.011%, 10.126% and 9.990%, respectively.

This approval is granted subject to any change which might result in necessary adjustments of the basic acreage figure to be agreed upon with respect to the 11th and 12th revisions, and further subject to the Standard Oil Company agreeing to extend for a period of sixty days after the submission by Standard Oil Company to the Commission of the revised map of the Rio Vista Field which the Standard Oil Company has agreed to submit, the time within which the State might make formal objection to the 11th to 44th revisions, inclusive, of the State's percentage allotment.

9. (Application to Purchase School Land, No. 4532, Sacramento Land District) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the sale for cash of the SW $\frac{1}{4}$  of SE $\frac{1}{4}$  and Lot 8 of Section 27, and Lots 2, 3 and 7 of Section 34, T. 23 N., R. 15 W., M.D.M., consisting of 197.60 acres in Medocino County, to Mr. Guy Redwine who made the highest offer. Mr. Redwine's offer of \$1,205.36 was received pursuant to the advertising for bids authorized by the Commission on June 9, 1944. All minerals contained in the land are reserved to the State.
