

16. (Pioneer Rubber Mills - New York Slough - No. P. R. C. 245) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the issuance of Lease No. P. R. C. 245 for a term of fifteen years for a 100 foot strip of tide and submerged lands containing 2.02 acres in New York Slough to the Pioneer Rubber Mills for the purpose of constructing a fill and utilizing the area for the storage of materials and supplies, at an annual rental of \$199.98 in accordance with the uniform policy of the Commission for the rental of tide and submerged lands for commercial and industrial purposes. The lease is to have a ten year renewal option on the part of the Lessee at reasonable terms and conditions to be determined by the State at the time of renewal and the granting of the lease is subject to the filing by the Lessee of a corporate surety bond in the amount of \$5,000. to guarantee performance and the removal at the termination of the lease of any structure. which may have been erected on the leased area.
