8. (Application for Permit to Conduct Goophysical Exploration on Tide and Submerged Lands, Orange County - Shell Oil Company - 7.0. No. 112) The Commission was informed that an application had been received from the Shell Oil Company, Incorporated, requesting permission to conduct seismograph exploration on State tidelands between Huntington Beach and Sunset Beach in Orange County.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Acting Executive Officer to execute and issue to the Shell dil Company, Inc., a permit for seismograph exploration operation on tidelands between Huntington Beach and Sunset Beach, Orange County, between the ordinary low water and ordinary high water marks of the Pacific Ocean for a period of thirty days for the consideration of the \$5.00 filing fee deposited heretofore, subject to the specific condition that the applicant agree to indemnify the State, and to assume any and all liability arising out of the proposed operation. The lessee is to file a \$100,000.00 hisbility and indemnity bond to protect the State.

9. (Application for Lease of Tide and Submerged Lands - Crescent City Harbor, Del Norte County - Robert E. Keans - W.O. No. 116) Hr. Robert E. Keans appeared upon behalf of the owners of approximately 3,000 feet of lands littoral to Crescent City Harbor in support of an application for a lease of tide and submerged lands to permit the construction of a wharf for the handling of lumber and other cargo.

Upon motion duly made and unanimously carried, a resolution was adopted deferring further consideration on this application until the next meeting in order that the relationship of the proposed project, legislation in progress, and any program of the Board of Supervisors of Del Norte County may be evaluated and a report rendered.

- 10. (Application for Lease of Corte Madera Ark Site No. 20 W.O. No. 45)
  Upon motion duly made and unanymously carried, a resolution was adopted authorizing the Acting Executive Officer to execute and issue a lease for Ark Site
  No. 20 to Mr. and Mrs. E. H. Anderson for a term of five years at a total annual
  rental of \$18.00 based upon the fact that only 3/7ths of the subject ark site
  is on State land. The rental is to be payable annually in advance and the lease
  is to provide specifically that the lease may not sublease the ark site without
  prior written approval of the Commission.
- 11. (Application for Assignment of Lease No. P.R.C. 281 Corte Madera Ark Site No. 5A) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Acting Executive Officer to approve the assignment of Lease No. P.R.G. 281 for Corte Madera Ark Site No. 5A from Mr. Lee G. Jamison to Mr. Manuel S. Amaral, Jr., upon payment of the statutory \$5.00 filing e.
