

14. (Partial Release by United States Navy of State School Land - San Bernardino County - Lease No. P.R.C. 146) The offer of the United States Navy to release to the State as of June 30, 1947, 6,419.28 acres of the area contained under Lease No. P.R.C. 146, was presented to the Commission.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Acting Executive Officer to accept and execute the release from the United States Navy to the State of 6,419.28 acres of the 11,386.56 acres included under Lease No. P.R.C. 146, effective as of June 30, 1947.

15. (Right of Way Easement, Modoc County, California Oregon Power Company - W.O. No. 1) The Commission was informed that the California Oregon Power Company had returned unexecuted the forms of right of way easement for a power line installation over Section 36, T. 44 N., R. 13 E., M.D.B. & M., as approved by the Commission on March 24, 1947, with a request that the application for the right of way be cancelled.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the cancellation of unexecuted right of way easement No. P.R.C. 318 over Section 36, T. 44 N., R. 13 E., M.D.B. & M., Modoc County.

16. (Application to Purchase State School Land, No. 10350, Los Angeles Land District, Riverside County, John Fitzpatrick - W.O. No. 54) The Commission was informed that whereas a protest had been filed to the application of Mr. John Fitzpatrick to purchase the  $N\frac{1}{2}$  of  $NW\frac{1}{4}$  and  $W\frac{1}{2}$  of  $NE\frac{1}{4}$  of Section 16, T. 5 S., R. 5 W., S.B.B. & M., that the bid of Mr. Fitzpatrick was the only one made pursuant to the public advertising of the offer to sell the subject land.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the sale of the  $N\frac{1}{2}$  of  $NW\frac{1}{4}$  and  $W\frac{1}{2}$  of  $NE\frac{1}{4}$  of Section 16, T. 5 S., R. 5 W., S.B.B. & M., containing 160 acres in Riverside County to the only bidder pursuant to the advertising, Mr. John Fitzpatrick, at a cash price of \$800.00, subject to all statutory reservations, including minerals.

17. (Application to Purchase Vacant School Land, No. 10359, Los Angeles Land District, San Bernardino County.-Harvey J. Stevenson) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the sale of Section 36, T. 6 N., R. 1 W., S.B.B. & M., containing 640 acres in San Bernardino County at a cash price of \$1,280.00 to Mr. Harvey J. Stevenson. Mr. Stevenson was the only bidder pursuant to the advertising. The land is to be sold subject to all statutory reservations, including minerals.
