

18. (Application to Purchase Vacant School Land, No. 10360, Los Angeles Land District, San Bernardino County - Ralph E. Swing) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the sale of Lot 4 (or SW $\frac{1}{4}$  of SE $\frac{1}{4}$ ) Section 36, T. 10 N., R. 22 E., S.B.B. & M., containing 40.07 acres in San Bernardino County at a cash price of \$200.35 to Mr. Ralph E. Swing. Mr. Swing was the only bidder pursuant to the advertising. The land is to be sold subject to all statutory reservations, including minerals.

19. (Grazing Lease Application, No. P.R.C. 1172, San Bernardino County - J. C. Cox, H. A. Foster and Lee Berry) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Acting Executive Officer to execute and issue a one year grazing lease to Messrs. J. C. Cox, H. A. Foster and Lee Berry for Section 36, T. 8 N., R. 1 E., S.B.B. & M., containing 640 acres in San Bernardino County, at an annual rental of twenty cents per acre. The applicants are to be required to pay the rental in advance at the time of execution of the lease.

20. (Grazing Lease Application, No. P.R.C. 1173, Tehama County - George L. Weston) Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Acting Executive Officer to execute and issue a five year grazing lease to Mr. G. L. Weston, the only bidder pursuant to the advertising, for Section 36, T. 28 N., R. 9 W., M.D.B. & M., containing 640 acres in Tehama County, at an annual rental of fifty cents per acre, with the lessee to pay the first and last years' rental at the time of execution of the lease.

21. (Sale of Vacant Federal Land obtained through Use of Base - Sacramento Land District - Mendocino County - William H. Nelson) Upon motion duly made and unanimously carried, a resolution was adopted approving the filing of an indemnity selection for the SW $\frac{1}{4}$  of SE $\frac{1}{4}$  of Section 20, T. 23 N., R. 16 W. M.D. B. & M., containing 40 acres in Mendocino County, and the sale of this land to Mr. William H. Nelson, the scrip applicant, at a cash price of \$200.00, subject to all statutory reservations, including minerals.

22. (Request for Transfer of Funds - State Controller) Request of the State Controller for authorization of a transfer of \$400,000.00, in accordance with Section 6816 of the Public Resources Code, from the accumulated balance of \$578,461.13 on April 28, 1947, was presented.

Upon motion duly made and unanimously carried, a resolution was adopted granting the authorization for the transfer as requested.
