14. (Application for Mineral Prospecting Permit - Harry F. Heather - San Bernardino County - W.O. 217) On January 9, 1948, the Commission approved the amendment of the mineral prospecting permit originally authorized on December 1, 1947 to Mr. Harry F. Heather covering Lots 5, 6 and 7 and the SE of NW of Section 36, T. 9 N., R. 4 E., S.B.B. & M., instead of Lots 3, 4 and 5 and the SE of NW of Section 36, T. 9 N., R. 4 E., S.B.B. & M., as originally approved, on the condition that such amendment would not conflict with any other application for prospecting permit currently on file. The application for a prospecting permit as filed by Mr. Loyd G. Adams, prior to the request for an amendment by Mr. Heather, embraces Lots 7 and 8, Section 36, T. 9 N., R. 4 E., S.B.B. & M., and therefore takes precedence over the request of Mr. Heather for Lot 7 of the same section.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Executive Officer to execute and issue a prospecting permit to Mr. Harry F. Heather on Lots 5 and 6 and the SE of NM of Section 36, T. 9 N., R. 4 E., S.B.B. & M., containing 120.61 acres, subject to the requirements of the Public Resources Code and providing that the royalties payable under any preferential lease issued upon discovery of commercially valuable minerals will be in accordance with the following schedule:

12% of market value at mine on 1 to 1,999 long tons per month
15% " " " " 2,000 to 3,999 long tons per month
17½ " " " " 4,000 to 5,999 " " " " "
20% " " " " " all tonnage in excess of 6,000 long
tons per month which value shall not be less than the reasonable
market value of all the mineral secured from the land and sold
or otherwise disposed of or held for sale or other disposition.

15. (Application for Mineral Prospecting Permit - Loyd G. Adams - San Bernardino County - W.O. 240) The Commission was informed that and application has been received from Mr. Loyd G. Adams of Newberry, for permission to prospect for clays and other non-metallic minerals on Lots 7 and 8, Section 36, T. 9 N., R. 4 E., S.B.B. & M., San Bernardino County, containing 80.78 acres. The subject lands are not known to contain commercially valuable minerals and the records of the Division of Mines do not disclose any prior mineral development in the immediate vicinity. Mr. Adams has deposited the rental of \$1.00 per acre for two years as prescribed by statute.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the Executive Officer to execute and issue a prospecting permit to Mr. Loyd G. Adams on Lots 7 and 8, Section 36, T. 9 N., R. 4 E., S.B.B. & M., containing 80.78 acres subject to the requirements of the Public Resources Code, and providing that the royalties payable under any preferential lease issued upon the discovery of commercially valuable minerals will be in accordance with the following schedule:

16. (Partial Assignment of School Land = Commercial Leases Nos. P.R.C. 258 and 339 - W.O. 253 - K. Donald Wyon - Vidal Junction, San Bernardino County) The Commission was informed that on January 9, 1948 the assignment of commercial leases on school land from Mr. Oscar Simon to Mr. K. Donald Wren. Request has now been received from Mr. Wren to assign an undivided one-half interest in these leases to Mr. Thomas B. Price.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the approval of an assignment of an undivided one-half interest in Vidal Junction Leases Nos. P.R.C. 258 and 339 from Mr. K. Donald Wren to Mr. Thomas B. Price for the single consideration of a \$5.00 filing fee.

17. (Grazing Lease Application No. P.R.C. 1189 - Modoc County - A. W. Carlsberg) The Commission was informed that an application has been received from Mr. A. W. Carlsberg of Alturas for a grazing lease for a term of five years on the SE and SE of S of Soction 36. T. 44 N., R. 13 E., M.D.M., containing 200 acres in Modoc County, and subsequent advertising thereof. The applicant has offered twenty-five cents per acre per year which is in excess of the minimum of five per cent of the appraised value of the land. No other bids were received.

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the issuance of a five year grazing lease to Mr. A. W. Carlsberg, the only bidder pursuant to advertising, at an annual rental of twenty-five cents per acre with the lessee to pay the first and last years rental at the time of execution of the lease.

18. (Sale of Vacant Federal Land, Obtained Through Use of Base, Selection No. 4633, Sacramento Land District, Shasta County - Milton J. Dollarhide and Ivan L. Fuller).

Upon motion duly made and unanimously carried, a resolution was adopted authorizing the filing with the Federal Government, and upon the approval of the selection, the sale of SW_{4}^{1} of NW_{4}^{1} of Section 17, T. 33 No. R. 2 E., M.D.M., to Messrs. Dollarhide and Fuller at a cash price to be set by the Commission after appraisal report, subject to all statutory reservations including minerals.
