

8. (DIVISION OF HIGHWAYS, REQUEST FOR APPROVAL OF HIGHWAY CROSSING, COLORADO RIVER, RIVERSIDE COUNTY - W.O. 411, P.R.C. 625.) The Division of Highways has requested approval, pursuant to Section 101.5 of the Streets and Highways Code, of a right of way for a highway bridge, XI-Riv-64-F, crossing the Colorado River easterly of Blythe, California, known as the Ehrenberg Bridge. The area to be occupied is 100 feet in width and approximately 500 feet in length to State boundary at the thread of the stream. It is presently the site of an existing bridge not under permit.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO APPROVE, PURSUANT TO SECTION 101.5 OF THE STREETS AND HIGHWAYS CODE, A HIGHWAY RIGHT OF WAY, XI-RIV-64-F, 100 FEET IN WIDTH AND APPROXIMATELY 500 FEET IN LENGTH, ACROSS THE COLORADO RIVER, EXTENDING TO THE STATE BOUNDARY OF THE STREAM EASTERLY OF BLYTHE, CALIFORNIA, NOW OCCUPIED BY THE EHRENBURG BRIDGE.

9. (DIVISION OF HIGHWAYS, REQUEST FOR APPROVAL OF HIGHWAY CROSSING, COLORADO RIVER, IMPERIAL COUNTY - W.O. 411, P.R.C. 626.) The Division of Highways has requested approval, pursuant to Sec. 101.5 of the Streets and Highways Code, of a right of way for a highway bridge, XI-IMP-27-B, crossing the Colorado River near Yuma, Arizona. The area to be occupied is 60 feet in width and approximately 170 feet in length to the State boundary of the thread of the stream. It is presently the site of an existing bridge not under permit.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO APPROVE, PURSUANT TO SECTION 101.5 OF THE STREETS AND HIGHWAYS CODE, A HIGHWAY RIGHT OF WAY, XI-IMP-27-B, 60 FEET IN WIDTH AND APPROXIMATELY 170 FEET IN LENGTH, ACROSS THE COLORADO RIVER, EXTENDING TO THE STATE BOUNDARY AT THE THREAD OF THE STREAM NEAR YUMA, ARIZONA.

10. (SALE OF VACANT FEDERAL LAND, OBTAINED THROUGH USE OF BASE, SCRIP APPLICATION NO. 10490, LOS ANGELES LAND DISTRICT, SAN BERNARDINO COUNTY, VICTORVILLE LIME ROCK COMPANY - S.W.O. 5260.) An offer has been received from the Victorville Lime Rock Company of Victorville, California, to purchase the $\frac{W}{2}$, $\frac{W}{2}$ of $SE\frac{1}{4}$, $\frac{W}{2}$ of $NE\frac{1}{4}$ of $SE\frac{1}{4}$ and $SW\frac{1}{4}$ of $SE\frac{1}{4}$ of $SE\frac{1}{4}$ of Section 26, T. 6 N., R. 4 W., S.B.M., containing 430 acres in San Bernardino County. This land may be obtained by the State from the Federal Government through use of base. The minimum price for scrip for this type of land has been set heretofore at \$5.00 per acre, cash. The Victorville Lime Rock Company has made an offer of \$2,150.00, or \$5.00 per acre.

The Assessor of San Bernardino County has assessed contiguous land at \$2.50 to \$5.00 per acre, thus indicating an appraised value of the land applied for of \$5.00 to \$10.00 per acre.

The subject land is largely on a gentle westerly slope with some outcroppings of rock, poor quality clay, with sparse desert growth. An appraisal by the Commission's staff indicates that the offer as made is adequate.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE SALE OF THE $\frac{W}{2}$, $\frac{W}{2}$ OF $SE\frac{1}{4}$, $\frac{W}{2}$ OF $NE\frac{1}{4}$ OF $SE\frac{1}{4}$ AND $SW\frac{1}{4}$ OF $SE\frac{1}{4}$ OF $SE\frac{1}{4}$ OF SECTION 26, T. 6 N., R. 4 W., S.B.M., TO THE VICTORVILLE LIME ROCK COMPANY AT THE APPRAISED CASH PRICE OF \$2,150.00, SUBJECT TO ALL STATUTORY RESERVATIONS INCLUDING MINERALS, UPON THE LISTING (CONVEYANCE) OF SAID LANDS TO THE STATE BY THE FEDERAL GOVERNMENT.
