(REVISION OF ITEM 3, PAGE 1403, MINUTES OF JULY 16, 1951, R. H. 25. EMMERSON & SON, HUMBOLDT COUNTY - W.O. 1071, P.R.C. 633.) On July 16, 1951, the Commission authorized the Executive Officer to issue to R. H. Emmerson & Son a lease covering approximately 32.5 acres of tide and submerged land in Mad River Slough, Kneeland Slough, and Cold Slough, in Humboldt County, for the purpose of driving piles in connection with the storage of logs. Effective period of lease was to be fifteen years at an annual rental, determined by appraisal, of \$214.50, with right of renewal for two additional periods of ten years each. Performance bond in the amount of \$2000 was to be furnished. Lease issuance was subject to receipt of waivers from the other littoral owners. A waiver has now been received from one of the littoral cuners for a period of five years only, However, the applicant has requested that the area to be leased be reduced to include only the frontage adjacent to the applicant's littoral lands and those for which a waiver was obtained. The area now desired consists of approximately 14.5 scres.

27. (APPLICATION FOR PERMIT TO DREDGE, AGUA HEDIONDA SLOUCH, SAN DIEGO COUNTY, OCEANSIDE-CARLSBAD SPORTSMAN'S CLUB - W.O. 1222, P.R.C. 715.) The dredging for which permit is requested was accomplished in 1950, a very minor portion being on sovereign lands of the State. The channel created permits passage of small craft to a harbor in Agua Hedionda Slough, reduces the stagnation of the water in the slough, and makes the slough useful. Filing fee has been paid.

UPON MOTION DULY MADE AND UNANIMOUSIN CARRIED, A RESOLUTION WAS ADOPTED AUTHORIZING THE EXECUTIVE OFFICER TO ISSUE TO THE OCEANSIDE-CARLSBAD SPORTSMAN'S CLUE, UPON ISSUANCE BY THE U.S. CORPS OF ENGINEERS OF THEIR PERMIT FOR THE OPERATIONS, A PERMIT TO DREDGE A CHANNEL IN THE PACIFIC OCEAN AT THE ENTRANCE TO AGUA HEDIONDA SLOUGH, SAN DIEGO COUNTY, THE CONSIDERATION BEING THE BENEFIT TO NAVIGATION.
