

25. (GRAZING LEASE APPLICATION, SAN BERNARDINO COUNTY, B & M CATTLE CO. - S.W.O. 5475, P.R.C. 1241.2.) Application was received on May 14, 1952, from B & M Cattle Co. of Cima, California, for a grazing lease for a term of five years on Section 16, T. 11 N., R. 13 E.; Sections 16 and 36, T. 12 N., R. 12 E.; Sections 16 and 36, T. 12 N., R. 13 E.; Sections 16 and 36, T. 12 N., R. 15 E.; Sections 16 and 36, T. 13 N., R. 13 E.; Section 16, and Frl. Section 36 (or $W\frac{1}{2}$, $E\frac{1}{2}$ of $E\frac{1}{2}$ and Lots 1, 2, 3 and 4), T. 13 N., R. 14 E.; Section 16, T. 14 N., R. 14 E.; Sections 16 and 36, T. 14 N., R. 15 E.; Frl. 26. (GRAZING LEASE APPLICATION, TEHAMA COUNTY, O. W. STONE - S.W.O. 5476, P.R.C. 1242.2.) Application was received on May 26, 1952, from O. W. Stone of Red Bluff, California, for a grazing lease for a term of five years on Section 16, T. 26 N., R. 8 W., M.D.M., containing 640 acres in Tehama County, at an annual rental of \$0.07+ per acre, which is equal to or exceeds the rental being charged by the Federal Government for comparable lands in that locality and adjoining the State lands. The carrying capacity in animal units on the subject land is about ten animals per section, and the lands are suitable for grazing only five or six months during the year.
