

7. (SALE OF VACANT FEDERAL LAND, OBTAINED THROUGH USE OF BASE, SCRIP APPLICATION NO. 4793, SACRAMENTO LAND DISTRICT, HUMBOLDT COUNTY, R. D. LANDERGEN - S.W.O. 5338.) An offer has been received from R. D. Landerger of Richmond, California, to purchase Lot 1 (or NW $\frac{1}{4}$  of NW $\frac{1}{4}$ ) of Section 19, T. 3 S., R. 1 E., H.M., containing 40.47 acres in Humboldt County. This land may be obtained by the State from the Federal Government through use of base. Mr. Landerger made an offer of \$202.35, or \$5 per acre.

The Assessor of Humboldt County has assessed contiguous land at \$2.50 per acre, plus timber value, thus indicating its appraised value to be \$5 per acre, plus the value of timber thereon.

An inspection and appraisal on file with the Commission by Harold Trott, an independent appraiser, of Eureka, California, dated February 12, 1954, sets the minimum value at \$10.08 per acre, plus timber value at \$300, thus establishing a total average of \$17.50 per acre. Mr. Landerger posted the necessary amount to meet the appraised value.
