5. (SALE OF VACANT SWAMP AND OVERFLOW LAND, LOCATION NO. 4262, FRESNO COUNTY, MILDRED FREER - S.W.O. 5968.) The following report was presented to the Commission:

"An offer has been received from Mildred Freer of Sanger, California, to purchase portions of Lots 8 and 9 lying between Swamp and Overflow Survey 48 and Swamp and Overflow Location 3316 in Section 9, T. 14 S., R. 23 E., M.D.M., containing 9.41 acres in Fresno County. Mrs. Freer made an offer of \$188.20, or \$20 per acre.

"The Assessor of Fresno County has assessed contiguous land at \$5 per acre, thus indicating its appraised value to be \$10 per acre.
