

13. (GEOLOGICAL SURVEY PERMIT, SANTA BARBARA COUNTY, EDWIN W. PAULEY - W. O. 2459, P.R.C. 1834.1.)

After presentation of Calendar Item 22 attached, upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO MR. EDWIN W. PAULEY A GEOLOGICAL SURVEY PERMIT CONFORMING TO OPERATING CONDITIONS DETERMINED BY THE COMMISSION MAY 18, 1956 FOR THE PERIOD DECEMBER 5, 1956 THROUGH JUNE 5, 1957 IN ORDER TO OBTAIN GEOLOGICAL INFORMATION INVOLVING DEPTHS IN EXCESS OF 500 FEET BELOW THE SURFACE OF THE OCEAN FLOOR IN THOSE TIDE AND SUBMERGED LANDS UNDER JURISDICTION OF THE COMMISSION LYING BETWEEN A LINE DRAWN PARALLEL TO AND THREE MILES WEST OF THE WEST BOUNDARY OF STATE OIL AND GAS LEASE P.R.C. 208.1, ELWOOD OIL FIELD, AND A LINE DRAWN DUE SOUTH FROM POINT CONCEPTION, SANTA BARBARA COUNTY. THE PERMITTEE IS TO REIMBURSE THE STATE LANDS COMMISSION FOR ALL OF ITS INSPECTION COSTS.

(GEOLOGICAL SURVEY PERMIT, SANTA BARBARA COUNTY, EDWIN W. PAULEY - W. O. 2459.)

An application has been received from Mr. Edwin W. Pauley for permission to conduct geological exploration from mobile marine equipment during a 180-day period beginning December 1, 1956. Permission has been requested to conduct core drilling operations below a depth of 500 feet below the ocean floor in those tide and submerged lands under jurisdiction of the Commission in the offshore area of Santa Barbara County extending from three miles west of State Oil and Gas Lease P.R.C. 208.1, Elwood Oil Field, to Point Conception. The statutory application filing fee has been paid by the applicant.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO MR. EDWIN W.
