

.23. (VACANT FEDERAL LAND OBTAINED THROUGH USE OF BASE, LIEU LAND APPLICATION NO. 4846, SACRAMENTO LAND DISTRICT, LAKE COUNTY, ERNEST M. McKEE, SR. - S.W.O. 5403.)

After presentation of Calendar Item 42 attached, upon motion duly made and unanimously carried, the following resolution was adopted:

THEREFORE, MR. McKEE IS GRANTED AN ADDITIONAL 30 DAYS, OR UNTIL JANUARY 14, 1957, TO DEPOSIT THE ADDITIONAL AMOUNT REQUIRED TO MEET THE APPRAISED PRICE OF THE LAND IN HIS APPLICATION NO. 4846, SACRAMENTO LAND DISTRICT, WITH THE STAFF TO REPORT TO THE COMMISSION AT THE JANUARY, 1957 MEETING, THE SUBSTANCE OF THE OPINION ISSUED BY THE ATTORNEY GENERAL'S OFFICE.

(VACANT FEDERAL LAND OBTAINED THROUGH USE OF BASE, LIEU LAND APPLICATION NO. 4846, SACRAMENTO LAND DISTRICT, LAKE COUNTY, ERNEST M. McKEE, SR. - S.W.O. 5403.)

At the meeting of the Commission held November 15, 1956, Sacramento, California, the Commission adopted the following action in connection with the subject State indemnity selection filed by Mr. McKee:

"THE ASSISTANT EXECUTIVE OFFICER IS AUTHORIZED TO GRANT, ON BEHALF OF THE COMMISSION, AN ADDITIONAL 30 DAYS, OR UNTIL DECEMBER 15, 1956, FOR MR. McKEE TO DEPOSIT THE ADDITIONAL MONEY REQUIRED TO MEET THE APPRAISED PRICE ON HIS LIEU LAND APPLICATION NO. 4846, OR OTHERWISE TO NEGOTIATE WITH MR. McKEE FOR ALTERNATIVE METHODS FOR CONCLUDING THIS TRANSACTION, WHICH ALTERNATIVE METHODS SHALL BE REPORTED TO THE COMMISSION FOR ITS ACTION AT A MEETING PRIOR TO DECEMBER 15, 1956."

At the meeting of August 15, 1956, the Commission directed the staff to submit certain questions relative to the aforesaid application to the Attorney General's Office for an opinion. This opinion request has been submitted and information received from the Attorney General's Office indicates that the written opinion will not be completed in time for consideration by the Commission at its meeting to be held December 5, 1956. However, we have been advised that the opinion will be issued during the month of December, 1956.

In view of the above, it is considered desirable to grant Mr. McKee an extension of time within which to deposit the additional money required, to meet the appraised price of the land in his application, in order that Commission consideration can be given to the matters in the opinion at its meeting in January, 1957.

IT IS THEREFORE RECOMMENDED THAT MR. McKEE BE GRANTED AN ADDITIONAL 30 DAYS, OR UNTIL JANUARY 14, 1957, TO DEPOSIT THE ADDITIONAL AMOUNT REQUIRED TO MEET THE APPRAISED PRICE OF THE LAND IN HIS APPLICATION NO. 4846, SACRAMENTO LAND DISTRICT, WITH THE STAFF TO REPORT TO THE COMMISSION AT THE JANUARY, 1957, MEETING, THE SUBSTANCE OF THE OPINION ISSUED BY THE ATTORNEY GENERAL'S OFFICE.
