

24. (WITHDRAWAL OF STATE LANDS FROM SALE FOR STATE DIVISION OF BEACHES AND PARKS, IMPERIAL COUNTY - GEO. - IMPERIAL CO.)

After presentation of Calendar Item 13 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

(WITHDRAWAL OF STATE LANDS FROM SALE FOR STATE DIVISION OF BEACHES AND PARKS, IMPERIAL COUNTY - GEO. - IMPERIAL CO.)

A request has been received from the State Division of Beaches and Parks, signed by Newton B. Drury, Chief, for withdrawal from public sale of lots 1, 2, 3 and 4 and SW $\frac{1}{4}$  of SW $\frac{1}{4}$  of Section 16, T. 13 S., R. 22 E., S.B.M., containing 163.72 acres in Imperial County.

The Division of Beaches and Parks has requested this withdrawal for the purpose of ultimately including this land within the Picacho proposed State park project on the Colorado River. We are informed this park project has received approval of the State Park Commission and negotiations are in progress which will provide for the transfer of jurisdiction of all federal lands within the project to the State Park Commission. It is expected that this latter transfer will occur in the very near future. Upon completion thereof, the State Park Commission proposes to apply for the purchase of the subject land.

Section 6210.2 of the Public Resources Code provides that "The Commission may withdraw from sale any of the public lands belonging to the State and may restore any or all public lands so withdrawn, or other public lands, for sale."
