8. (SALE OF VACANT SCHOOL LAND, APPLICATION NO. 5286, SACRAMENTO LAND DISTRICT, SISKIYOU COUNTY, JOHN C. FARRELL - S.W.O. 6501.)

After presentation of Calendar Item 9 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

APPLICATION 5286, S.W.O. 6501, OF JOHN C. FARRELL, FOR THE PURCHASE OF LOTS 2 AND 3 OF SECTION 16, T. 48 N., R. 1 E., M.D.M., CONTAINING 58.78 ACRES IN SISKIYOU COUNTY, IS REJECTED AND ALL DEPOSITS ARE TO BE REFUNDED EXCEPT THE \$5 FILING FEE, AND SAID LAND IS WITHDRAWN FROM PUBLIC SALE AND HELD FOR SALE TO THE STATE DEPARTMENT OF FISH AND GAME UNDER APPLICATION NO. 5315, S.W.O. 6656, AT THE APPRAISED MARKET VALUE WITHOUT COMPETITIVE BIDDING.

(SALE OF VACANT SCHOOL LAND, APPLICATION NO. 5286, SACRAMENTO LAND DISTRICT, SISKIYOU COUNTY, JOHN C. FARRELL - S.W.O. 6501.)

An offer has been received from John C. Farrell of Sacramento, California, to purchase Lots 2 and 3 of Section 16, T. 48 N., R. 1 E., M.D.M., containing 58.78 acres in Siskiyou County. The applicant made an offer of \$117.56, or \$2 per acre.

On May 20, 1957 an application (5315, Sacramento Land District, S.W.O. 6656) was filed on behalf of Department of Fish and Game, wherein an offer of \$5 per acre was made.

Subsequently, a letter under date of May 22, 1957 was received from the Wildlife Conservation Board, through the Department of Fish and Game, requesting the opportunity to purchase the lands, and indicating that they are desired and needed for public use in connection with Indian Tom Lake as a waterfowl hunting area. We are further advised that these two lots would provide suitable access to the lands and waters of Indian Tom Lake, which is under jurisdiction of the Bureau of Reclamation. Further, an agreement is proposed between the Bureau and the Department of Fish and Game permitting the latter agency to control and operate the lake as a public shooting area. Furthermore, it has been represented that acquisition of the land would provide a good addition to the Department of Fish and Game's group of public hunting areas.

IT IS RECOMMENDED THAT APPLICATION 5286, S.W.O. 6501, OF JOHN C. FARRELL, FOR THE PURCHASE OF LOTS 2 AND 3 OF SECTION 16, T. 48 N., R. 1 E., M.D.M., CONTAINING 58.78 ACRES IN SISKIYOU COUNTY, BE REJECTED AND ALL DEPOSITS REFUNDED EXCEPT THE \$5 FILING FEE, AND THAT SAID LAND BE WITHDRAWN FROM PUBLIC SALE AND HELD FOR SALE TO THE STATE DEPARTMENT OF FISH AND GAME UNDER APPLICATION NO. 5315, S.W.O. 6656, AT THE APPRAISED MARKET VALUE WITHOUT COMPETITIVE BIDDING.
