MINUTE ITEM

7. (GEOLOGICAL SURVEY PERMIT, SANTA BARBARA COUNTY, SIGNAL OIL AND GAS COMPANY - W. O. 2666, P.R.C. 1962.1.)

After presentation of Calendar Item 21 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO SIGNAL OIL AND GAS COMPANY A GEOLOGICAL SURVEY PERMIT FOR THE PERIOD JULY 15, 1957 TO JANUARY 15, 1958, INCLUSIVE, FOR THE CONDUCT OF GEOLOGICAL EXPLORATIONS, INCLUDING CORE DRILLING, PROSPECT HOLES, ELECTRIC LOGGING, SIDEWALL SAMPLING AND OTHER OPERATIONS (BUT NOT INCLUDING GEOPHYSICAL OPERATIONS), IN ORDER TO GAIN GEOLOGICAL INFORMATION INVOLVING DEPOSITS IN EXCESS OF 500 FEET BELOW THE SURFACE OF THE OCEAN FLOOR IN TIDE AND SUBMERGED LANDS IN SANTA BARBARA COUNTY INCLUDED WITHIN THE EXTERIOR LIMITS OF OIL AND GAS LEASE P.R.C. 208.1.

AUTHORIZATION OF THE PROPOSED EXPLORATIONS SHALL BE SUBJECT TO THE FOLLOWING REQUIREMENTS:

1. COPIES OF ALL EXPLORATION RESULTS, LOGS AND RECORDS SHALL BE MADE AVAILABLE TO AND FILED WITH THE STATE AS REQUIRED FOR ALL WELL DATA UNDER OIL AND GAS LEASE P.R.C. 208.1.
2. ALL DRILLING PROGRAMS SHALL BE APPROVED AS REQUIRED FOR WELLS DRILLED UNDER LEASE P.R.C. 208.1.

(GEOLOGICAL SURVEY PERMIT, SANTA BARBARA COUNTY, SIGNAL OIL AND GAS COMPANY - W. O. 2666.)

An application has been received from the Signal Oil and Gas Company to conduct geological explorations from mobile marine equipment during the period July 15, 1957 to January 15, 1958, inclusive, on the area held by the applicant under Oil and Gas Lease P.R.C. 208.1, Santa Barbara County.

Under the terms and conditions of Oil and Gas Lease P.R.C. 208.1, wells may be drilled only from upland drillsites or filled lands. The statutory application filing fee has been paid by the applicant.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO SIGNAL OIL AND GAS COMPANY A GEOLOGICAL SURVEY PERMIT FOR THE PERIOD JULY 15, 1957 TO JANUARY 15, 1958, INCLUSIVE, FOR THE CONDUCT OF GEOLOGICAL EXPLORATIONS, INCLUDING CORE DRILLING, PROSPECT HOLES, ELECTRIC LOGGING, SIDEWALL SAMPLING AND OTHER OPERATIONS (BUT NOT INCLUDING GEOPHYSICAL OPERATIONS), IN ORDER TO GAIN GEOLOGICAL INFORMATION INVOLVING DEPOSITS IN EXCESS OF 500 FEET BELOW THE SURFACE OF THE OCEAN FLOOR IN TIDE AND SUBMERGED LANDS IN SANTA BARBARA COUNTY INCLUDED WITHIN THE EXTERIOR LIMITS OF OIL AND GAS LEASE P.R.C. 208.1.

AUTHORIZATION OF THE PROPOSED EXPLORATIONS SHALL BE SUBJECT TO THE FOLLOWING REQUIREMENTS:

1. COPIES OF ALL EXPLORATION RESULTS, LOGS AND RECORDS SHALL BE MADE AVAILABLE TO AND FILED WITH THE STATE AS REQUIRED FOR ALL WELL DATA UNDER OIL AND GAS LEASE P.R.C. 208.1.
2. ALL DRILLING PROGRAMS SHALL BE APPROVED AS REQUIRED FOR WELLS DRILLED UNDER LEASE P.R.C. 208.1.
