After presentation of Calendar Item 23 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO GRANT A PERMIT TO THE PALOS VERDES CORPORATION AND THE CAPITAL COMPANY, PURSUANT TO SECTION 6321 OF THE PUBLIC RESOURCES CODE, FOR THE CONSTRUCTION, USE AND MAINTENANCE OF A SEAWALL AND BACKFILL OF ABOUT 23 ACRES, TO THE MEAN HIGH TIDE LINE IN PORTUGUESE BEND, LOS ANGELES COUNTY, SAID FACILITY TO BE ABOUT 2,000 FEET IN LENGTH, APPROXIMATELY PARALLELING THE COAST AT PORTUGUESE BEND, THE LOCATION TO BE APPROVED BY THE STAFF, TO ASSIST IN PROTECTING THE UPLAND PROPERTY FROM LANDSLIDES.

(APPLICATION TO CONSTRUCT SEAWALL AND BACKFILL TO MEAN HIGH TIDE LINE AT PORTUGUESE BEND, LOS ANGELES COUNTY, PALOS VERDES CORPORATION AND CAPITAL COMPANY - W. O. 2664.)

An application has been received from the Palos Verdes Corporation and the Capital Company, owners of the adjoining upland, to construct a seawall on tide and submerged lands of the Pacific Ocean in Portuguese Bend and extending approximately 2,000 feet westerly from the west line of Crenshaw Boulevard extended southerly, the land between the seawall and the upland to be filled to the height of the seawall.

The purpose of the installation is to provide a barrier to assist in preventing landslides of the upland area, which rises steeply from the shore. The statutory filing fee and the expense deposit required by regulation have been paid. Section 6321 of the Public Resources Code provides for construction of the type proposed, no rental being required, and fees to be no more than required for examination of plans and performance of such other duties as may be necessary.
