MINUTE ITEM

11. (APPLICATION TO EXTEND JETTY AT CAMP PENDLETON HARBOR, NEAR OCEANSIDE, SAN DIEGO COUNTY, U. S. NAVY, ELEVENTH NAVAL DISTRICT - W. O. 2677, P.R.C. 635.9.)

Following presentation of Calendar Item 15 attached, the Acting Executive Officer informed the Commission that Section 6321 of the Public Resources Code provides that such authorization may be granted for a structure if the structure would not unreasonably interfere with the uses and purposes of the people reserved to the State, and recommended that the Commission-make a finding to this effect.

UPON MOTION DULY MADE AND UNANIMOUSLY CARRIED, THE FOLLOWING RESOLUTION WAS ADOPTED:

THE COMMISSION FINDS THAT THE PROPOSED CONSTRUCTION WILL NOT UNREASONABLY INTERFERE WITH THE USES AND PURPOSES OF THE PEOPLE RESERVED TO THE STATE. THE ACTING EXECUTIVE OFFICER IS AUTHORIZED TO GRANT A PERMIT TO THE U.S. NAVY, ELEVENTH NAVAL DISTRICT, FOR THE CONSTRUCTION, USE AND MAINTENANCE OF AN EXTENSION OF A JETTY 2,300 FEET IN LENGTH SOUTHERLY FROM THE BOAT BASIN, AND PARALLELING THE SHORE LINE AT CAMP PENDLETON, NEAR OCEANSIDE, SAN DIEGO COUNTY, THE CONSIDERATION BEING THE BENEFIT TO THE HARBOR FACILITIES AT CAMP PENDLETON, AND RELIEF OF THE ERCSION PROBLEM AT OCEANSIDE.

(APPLICATION TO EXTEND JETTY AT CAMP PENDLETON HARBOR, NEAR OCEANSIDE, SAN DIEGO COUNTY, U. S. NAVY, ELEVENTH NAVAL DISTRICT - W. O. 2677.)

An application has been received from the Eleventh Naval District to extend the existing jetty 2,300-feet-southerly and paralleling the shore line from the boat basin at Camp Pendleton Harbor. The proposed extension, a rubble and rock mound type, will be constructed from plans prepared by the U. S. Corps of Engineers. Section 6321 of the Public Resources Code provides for such construction.

This project is in conjunction with the dredging of the channel, landward, adjoining and paralleling the proposed jetty extension, the permit for which was issued as P.R.C. 635.9. No fees or rental are required, the consideration being the benefit to the harbor racilities at Camp Pendleton and relief of the erosion problem at Oceanside.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO GRANT A PERMIT TO THE U.S. NAVY, ELEVENTH NAVAL DISTRICT, FOR THE CONSTRUCTION, USE AND MAINTENANCE OF AN EXTENSION OF A JETTY 2,300 FEET IN LENGTH SOUTHERLY FROM THE BOAT BASIN, AND PARALLELING THE SHORE LINE AT CAMP PENDLETON, NEAR OCEANSIDE, SAN DIEGO COUNTY, THE CONSIDERATION BEING THE BENEFIT TO THE HARBOR FACILITIES AT CAMP PENDLETON, AND RELIEF OF THE EROSION PROBLEM AT 'OCEANSIDE.
