(REQUEST FOR WITHDRAWAL FROM SALE OF VACANT STATE SCHOOL LAND, SAN BERNARDINO COUNTY - S.W.O.'s 6567, 6573, 6671.)

Applications S.W.O. 6567, 6573, and 6671 have been received to purchase Section 36, Township 1 North, Range 22 East, S.B.B.& M., near Vidal, San Bernardino County. Pursuant to these applications, field appraisal of the area has shown that the main-line track of the Atchison, Topeka and Santa Fe Railway Company traverses the section. The Railway Company does not appear to have any record right-of-way over the land, having in the past relied upon a Federal filing approved by the Secretary of the Interior in 1911.
