SEPTEMBER 7, 1957 TO 5 P.M. SEPTEMBER 13, 1957, AND AUTHCRIZES THE ISSUANCE OF A NOTICE TO ALL APPLICANTS ALLOWING 50 DAYS FROM SEPTEMBER 13, 1957, OR UNTIL 5 P.M. NOVEMBER 2, 1957, WITHIN WHICH THE APPLICANTS MAY SUBMIT THE REQUIRED AMOUNTS TO MEET THE APPRAISED VALUES ESTABLISHED BY THE STAFF. FURTHER, THE APPLICATIONS ARE TO BE CANCELLED AS TO THOSE APPLICANTS WHO FAIL TO MEET THE APPRAISED VALUE WITHIN THE TIME SPECIFIED AND DEPOSITS REFUNDED LESS EXPENSES INCURRED TO THE DATE OF CANCELLATION, WHEREUPON THE LANDS THEREIN WILL BE OFFERED FOR SALE AT COMPETITIVE BIDDING, UNDER THE RULES AND REGULATIONS GOVERN-ING THE SALE OF VACANT STATE SCHOOL LAND."
