

MINUTE ITEM

20. (WITHDRAWAL OF STATE LANDS FOR STATE DEPARTMENT OF WATER RESOURCES, S.W.O. 6260, GEO.-LAKE COUNTY.)

After presentation of Calendar Item 10 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

WITHDRAWAL FROM PUBLIC SALE OF THE $W\frac{1}{2}$ OF $SE\frac{1}{4}$ OF SECTION 19, $SW\frac{1}{4}$ OF $NW\frac{1}{4}$ AND $NW\frac{1}{4}$ OF $SW\frac{1}{4}$ OF SECTION 27, $N\frac{1}{2}$ OF $S\frac{1}{2}$ OF SECTION 28, $E\frac{1}{2}$ OF $NW\frac{1}{4}$, $W\frac{1}{2}$ OF $NE\frac{1}{4}$ AND $NE\frac{1}{4}$ OF $NE\frac{1}{4}$ OF SECTION 29, $N\frac{1}{2}$ OF $NE\frac{1}{4}$ OF SECTION 30, T. 13 N., R. 5 W., AND THE $NW\frac{1}{4}$ OF $SW\frac{1}{4}$ OF SECTION 12, $NE\frac{1}{4}$ OF $NW\frac{1}{4}$ OF SECTION 15, AND LOT 1 OF SECTION 24, T. 13 N., R. 6 W., M.D.M., CONTAINING 709.37 ACRES IN LAKE COUNTY, AS AUTHORIZED BY THE COMMISSION AT ITS MEETING OF JULY 2, 1956, IS EXTENDED UNTIL DECEMBER 31, 1958, AND THE $NE\frac{1}{4}$ OF $NW\frac{1}{4}$ OF SECTION 29, T. 13 N., R. 6 W., M.D.M., CONTAINING 40 ACRES, IS INCLUDED THEREIN. FURTHER, IN THE EVENT THE LANDS EMBRACED IN APPLICATION 5202, SACRAMENTO LAND DISTRICT, S.W.O. 6260, ARE RESTORED TO ENTRY, FRANCES CAIN, THE APPLICANT, IS TO BE ACCORDED THE RIGHT OF FILING THE FIRST APPLICATION THEREON AS AUTHORIZED BY RESOLUTION ADOPTED BY THE COMMISSION AT ITS MEETING OF AUGUST 5, 1956.

(WITHDRAWAL OF STATE LANDS FOR STATE DEPARTMENT OF WATER RESOURCES, S.W.O. 6260, GEO-LAKE COUNTY.)

Pursuant to the request of the State Division of Water Resources, the Commission at its meeting held July 2, 1956 (Minute Item 18, page 2727) withdrew from public sale until December 31, 1957 the $W\frac{1}{2}$ of $SE\frac{1}{4}$ of Section 19, $SW\frac{1}{4}$ of $NW\frac{1}{4}$ and $NW\frac{1}{4}$ of $SW\frac{1}{4}$ of Section 27, $N\frac{1}{2}$ of $S\frac{1}{2}$ of Section 28, $E\frac{1}{2}$ of $NW\frac{1}{4}$, $W\frac{1}{2}$ of $NE\frac{1}{4}$ and $NE\frac{1}{4}$ of $NE\frac{1}{4}$ of Section 29, $N\frac{1}{2}$ of $NE\frac{1}{4}$ of Section 30, T. 13 N., R. 5 W., M.D.M., and the $NW\frac{1}{4}$ of $SW\frac{1}{4}$ of Section 12, $NE\frac{1}{4}$ of $NW\frac{1}{4}$ of Section 15 and Lot 1 of Section 24, T. 13 N., R. 6 W., M.D.M., Lake County, California, containing a total of 709.37 acres.

At that time the State Division of Water Resources requested the withdrawal by reason of a cooperative investigation under way between the Division and the County of Yolo with the objective of presenting a plan or plans for the conservation and control of the waters of Cache Creek. The Division of Water Resources further advised that a dam at the Wilson Valley Site embracing the above parcels might become an integral part of the plan of improvement to be proposed.

In adopting the resolution withdrawing the aforesaid lands from public sale, the Commission also rejected an application to purchase the $NW\frac{1}{4}$ of $SW\frac{1}{4}$ of Section 12, $NE\frac{1}{4}$ of $NW\frac{1}{4}$ of Section 15 and Lot 1 of Section 24, T. 13 N., R. 6 W., M.D.M., containing 109.37 acres, filed by Frances Cain (Application No. 5202, Sacramento Land District, S.W.O. 6260).

At its meeting of August 15, 1956 (Minute Item 38, page 2797) the Commission adopted a resolution according Frances Cain the right to become the first applicant for the lands embraced in her cancelled application in the event they are later restored to public entry.

A letter dated November 1, 1957 from William L. Berry, Chief, Division of Resources Planning, Department of Water Resources, requests that the withdrawal above referred to be extended to December 31, 1958. One additional parcel described as the $NE\frac{1}{4}$ of $NW\frac{1}{4}$ of Section 29, T. 13 N., R. 6 W., M.D.M., containing 40 acres, has been added to the lands in the original request. The letter states that the Department of Water Resources is now completing a report with the objective of comparing a dam and reservoir project in Wilson Valley with a similar project in Capay Valley above the town of Guinda. This Division is informed that the extension of time requested would permit the Department to complete its report and allow time for presentation of the findings of the investigation to interested parties and local agencies.
