State Oil and Gas Lease P.R.C. 1551,1 was issued to the Richfield Oil Corporation, the Hancock Oil Company and the Signal Oil and Gas Company on August 16, 1955, pursuant to Division 6 of the Public Resources Code. The Signal Oil and Gas Company is the designated operator of the lease.

An application has been received from the Signal Oil and Gas Company requesting that the terms of the lease be modified as provided for under Section 6873 of the Public Resources Code, as amended by Chapter 104 of the Statutes of 1957, in order that the lesses may take advantage of the more flexible operating and development conditions specified.

It is the opinion of the office of the Attorney General that Oil and Gas Lease P.R.C. 1551.1 may be modified in accordance with the provisions of Section 6873 of the Public Resources Code.
