

MINUTE ITEM

20. (APPLICATION TO USE EXCAVATED MATERIAL, YOLO COUNTY ROAD COMMISSIONER, SACRAMENTO RIVER, YOLO COUNTY - W. O. 3023, P.R.C. 2262.9.)

After presentation of Calendar Item 32 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE YOLO COUNTY ROAD COMMISSIONER A PERMIT, SUBJECT TO ISSUANCE OF A PERMIT BY CORPS OF ENGINEERS, FOR THE PERIOD OCTOBER 14, 1958 TO JANUARY 1, 1960, INCLUSIVE, TO EXCAVATE FROM THE CHANNEL OF THE SACRAMENTO RIVER, YOLO COUNTY, MATERIAL TO BE USED ON COUNTY ROADS. THE PERMIT SHALL LIMIT THE EXCAVATED MATERIAL TO A MAXIMUM OF 50,000 CUBIC YARDS. THE CONSIDERATION FOR THIS PERMIT IS THAT THE EXTRACTION WILL BE BENEFICIAL TO NAVIGATION.

(APPLICATION TO USE EXCAVATED MATERIAL, YOLO COUNTY ROAD COMMISSIONER,
SACRAMENTO RIVER, YOLO COUNTY - W. O. 3023.)

An application has been received from the Yolo County Road Commissioner for a permit to use material excavated from the channel of the Sacramento River on county roads in the Clarksburg area. The Corps of Engineers has reported that they will issue a permit for the proposed operations. The majority of this work is on Federal Aid Secondary Projects for which the State will advertise for bids. Section 6303, Public Resources Code, provides in part: "When a contractor or permittee has a contract with or a permit from the Federal Government or any authorized public agency to dredge navigable streams for the improvement of navigation, the commission may, when in the best interests of the State, allow such contractor or permittee to have sand, gravel, or other spoils dredged from the sovereign lands of the State located within the areas specified in such contract or permit without paying a royalty therefor. The amounts of sand, gravel or other spoils so removed from sovereign lands shall not exceed those specified in the contract or permit."

The specific area for the proposed operations is at Mile 39.7, approximately 2.3 miles downstream from Clarksburg, California. The applicant has estimated that approximately 50,000 cubic yards of material will be required and that the removal of the material will be completed by January 1, 1960.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO THE YOLO COUNTY ROAD COMMISSIONER A PERMIT, SUBJECT TO ISSUANCE OF A PERMIT BY CORPS OF ENGINEERS, FOR THE PERIOD OCTOBER 14, 1958 TO JANUARY 1, 1960, INCLUSIVE, TO EXCAVATE FROM THE CHANNEL OF THE SACRAMENTO RIVER, YOLO COUNTY, MATERIAL TO BE USED ON COUNTY ROADS.
