

MINUTE ITEM

31. (WITHDRAWAL OF STATE LANDS FOR STATE DEPARTMENT OF WATER RESOURCES, LAKE COUNTY - S.W.O. 6260.)

After consideration of Calendar Item 18 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE WITHDRAWAL FROM PUBLIC SALE ON BEHALF OF THE STATE DEPARTMENT OF WATER RESOURCES OF THE  $W\frac{1}{2}$  OF  $SE\frac{1}{4}$  OF SECTION 19,  $SW\frac{1}{4}$  OF  $NW\frac{1}{4}$ , AND  $NW\frac{1}{4}$  OF  $SW\frac{1}{4}$  OF SECTION 27,  $N\frac{1}{2}$  OF  $S\frac{1}{2}$  OF SECTION 28,  $E\frac{1}{2}$  OF  $NW\frac{1}{4}$ ,  $W\frac{1}{2}$  OF  $NE\frac{1}{4}$ , AND  $NE\frac{1}{4}$  OF  $NE\frac{1}{4}$  OF SECTION 29,  $N\frac{1}{2}$  OF  $NE\frac{1}{4}$  OF SECTION 30, T. 13 N., R. 5 W., AND THE  $NW\frac{1}{4}$  OF  $SW\frac{1}{4}$  OF SECTION 12,  $NE\frac{1}{4}$  OF  $NW\frac{1}{4}$  OF SECTION 15, LOT 1 OF SECTION 24, AND  $NE\frac{1}{4}$  OF  $NW\frac{1}{4}$  OF SECTION 29, T. 13 N., R. 6 W., M.D.M., CONTAINING 749.37 ACRES IN LAKE COUNTY, IS EXTENDED UNTIL DECEMBER 31, 1961. IN THE EVENT THE LANDS EMERACED IN CANCELED APPLICATION 5202, SACRAMENTO LAND DISTRICT, S.W.O. 6260 ARE RESTORED TO ENTRY, FRANCES CAIN, THE APPLICANT, IS TO BE ACCORDED THE RIGHT OF FILING THE FIRST APPLICATION THEREON, AS AUTHORIZED BY RESOLUTION ADOPTED BY THE COMMISSION AT THE MEETING OF AUGUST 5, 1956.

(WITHDRAWAL OF STATE LANDS FOR STATE DEPARTMENT OF WATER RESOURCES, LAKE COUNTY - S.W.O. 6260.)

Pursuant to the request of the State Department of Water Resources (at that time the Division of Water Resources), the Commission at its meeting on July 2, 1956 (Minute Item 18, page 2727), withdrew from public sale until December 31, 1957, the  $W\frac{1}{2}$  of  $SE\frac{1}{4}$  of Section 19,  $SW\frac{1}{4}$  of  $NW\frac{1}{4}$ , and  $NW\frac{1}{4}$  of  $SW\frac{1}{4}$  of Section 27,  $N\frac{1}{2}$  of  $S\frac{1}{2}$  of Section 28,  $E\frac{1}{2}$  of  $NW\frac{1}{4}$ ,  $W\frac{1}{2}$  of  $NE\frac{1}{4}$ , and  $NE\frac{1}{4}$  of  $NE\frac{1}{4}$  of Section 29,  $N\frac{1}{2}$  of  $NE\frac{1}{4}$  of Section 30, T. 13 N., R. 5 W., and the  $NW\frac{1}{4}$  of  $SW\frac{1}{4}$  of Section 12,  $NE\frac{1}{4}$  of  $NW\frac{1}{4}$  of Section 15, Lot 1 of Section 24, T. 13 N., R. 6 W., M.D.M., Lake County, California, containing a total of 709.37 acres.

At the meeting held December 12, 1957 (Minute Item 20, page 3708), the Commission granted an extension of the withdrawal of the above-described lands from public sale until December 31, 1958, and included therein an additional parcel described as the  $NE\frac{1}{4}$  of  $NW\frac{1}{4}$  of Section 29, T. 13 N., R. 6 W., M.D.M., bringing the total acreage of the lands withdrawn to 749.37 acres.

The original withdrawal request and the extension thereof were requested by the State Department of Water Resources in view of a cooperative investigation under way between that Department and the County of Yolo, with the objective of presenting a plan or plans for the conservation control of the waters of Cache Creek. The Department of Water Resources advises that a dam at the Wilson Valley site, embracing the above parcels, might become an integral part of the plan of improvement to be proposed.

In adopting the original resolution withdrawing the aforesaid lands from public sale, the Commission rejected an application to purchase the  $NW\frac{1}{4}$  of  $SW\frac{1}{4}$  of Section 12,  $NE\frac{1}{4}$  of  $NW\frac{1}{4}$  of Section 15, and Lot 1 of Section 24, T. 13 N., R. 6 W., M.D.M., containing 109.37 acres, filed by Frances Cain (Application No. 5202, Sacramento Land District, S.W.O. 6260). By resolution adopted at the meeting of August 15, 1956 (Minute Item 38, page 2797), the Commission accorded to Frances Cain a preferential right to reapply for the lands at such time as they might be restored to public sale.

A letter dated December 23, 1958, from William L. Berry, Chief, Division of Resources Planning, Department of Water Resources, requests an extension of the aforesaid withdrawal to December 31, 1961. The letter states that the Department of Water Resources is continuing its investigation of the feasibility of constructing a major storage reservoir at the Wilson Valley site on Cache Creek. In addition, this Division is informed that the extension of time requested would permit the Department to complete its report, which is not expected to be available before June, 1960, and would allow time for local interests to analyze the report and to take action on a development program.

IT IS FURTHER RECOMMENDED THAT IN THE EVENT THE LANDS EMBRACED IN CANCELED APPLICATION 5202, SACRAMENTO LAND DISTRICT, S.W.O. 6260, ARE RESTORED TO ENTRY, FRANCES CAIN, THE APPLICANT, BE ACCORDED THE RIGHT OF FILING THE FIRST APPLICATION THEREON, AS AUTHORIZED BY RESOLUTION ADOPTED BY THE COMMISSION AT THE MEETING OF AUGUST 5, 1956.
