PURSUANT TO THE PROVISIONS OF SECTION 7952 OF THE PUBLIC RESOURCES CODE, THE EXECUTIVE OFFICER IS AUTHORIZED TO APPROVE THE RESURVEY OF THE NORTHERLY COMMON BOUNDARY LINE BETWEEN STATE LANDS AND TIDELAND LOCATION NO. 131 AS SHOWN ON SHEETS 1 AND 2 OF 2 OF A MAP OF SURVEY OF LOCATION NO. 131 AND NO. 220 OF STATE TIDELANDS, SAN LUIS OBISPO COUNTY, DATED SEPTEMBER 1958, PREPARED BY TRAVIS L. MANNING, REGISTERED CIVIL ENGINEER NO. 7676, A COPY OF WHICH MAP IS ON FILE IN THE OFFICES OF THE STATE LANDS DIVISION.

The approval of a correctory survey for patented tidelands has been requested pursuant to Section 7952 of the Public Resources Code. The position of the northerly common boundary line between Tideland Location No. 131 and State lands in Morro Bay has been reviewed by the State Lands Division and is correctly shown on Sheets 1 and 2 of 2 of the "Map of Survey of Location No. 131, State Tidelands, San Luis Obispo County, Township 30 South, Range 10 East, Mount Diablo Meridian, Sections 11, 12, 13 and 14, State of California, and of Location No. 220, State Tidelands, San Luis Obispo County, Township 30 South, Range 11 East, Mount Diablo Meridian, Sections 7 and 18, State of California", dated September 1958. The State of California is not concerned with the survey of the Mean High Tide Line as it is shown on this map since this line is outside of the area of State jurisdiction.
