3. APPLICATION FOR LIFE-OF-STRUCTURE PERMIT FOR PIER, TIDE AND SUBMERGED LANDS, SEAL BEACH, ORANGE COUNTY, CITY OF SEAL BEACH - W.O. 3096, P.R.C. 2348.9.

After consideration of Calendar Item 5 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE CITY OF SEAL BEACH A LIFE-OF-STRUCTURE PERMIT FOR 25 YEARS, BEGINNING OCTOBER 4, 1958. THE PERMIT IS TO COVER A STRIP OF TIDE AND SUBMERGED LANDS CONSISTING OF APPROXIMATELY 3.45 ACRES, 80 FEET WIDE AND APPROXIMATELY 1,880 FEET LONG, EXTENDING OCEAN-WARD, THE CENTERLINE OF WHICH IS THE CENTERLINE OF MAIN STREET, EXTENDED, IN SEAL BEACH. THE PERMIT IS TO COVER THE OPERATION AND MAINTENANCE OF A MUNI-CIPAL PIER. THE CONSIDERATION IS THE PUBLIC USE AND BENEFIT.

(APPLICATION FOR LIFE-OF-STRUCTURE PERMIT FOR PIER, TIDE AND SUBMERGED LANDS, SEAL BEACH, ORANGE COUNTY, CITY OF SEAL BEACH - W.O. 3096.)

An application has been received from the City of Seal Beach, as littoral owner, for a life-of-structure permit covering a pier which was constructed in 1938. The pier extends 1,880 feet oceanward from Main Street in Seal Beach, the centerline of said pier being the extension of Main Street. Agreement 675/PC-2.9, previously issued for this pier, expired October 3, 1958. No fees or rentals are required.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO THE CITY OF SEAL BEACH A LIFE-OF-STRUCTURE PERMIT FOR 25 YEARS, BEGINNING OCTOBER 4, 1958. THE PERMIT IS TO COVER A STRIP OF TIDE AND SUBMERGED LANDS CONSISTING OF APPROXIMATELY 3.45 ACRES, 80 FEET WIDE AND APPROXIMATELY 1,880 FEET LONG, EXTENDING OCEANWARD, THE CENTERLINE OF WHICH IS THE CENTERLINE OF MAIN STREET, EXTENDED, IN SEAL BEACH.
