5. APPLICATION FOR BRIDGE RIGHT-OF-WAY ACROSS SUBMERGED LANDS OF THE TUOLUMNE RIVER IN SECTION 2, T. 4 S., R. 10 E., M.D.B.& M., STANISLAUS COUNTY - W.O. 3114, P.R.C. 2350.9.

After consideration of Calendar Item 7 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO GRANT TO STANISLAUS COUNTY A 49-YEAR LIFE-OF-STRUCTURE PERMIT FOR A BRIDGE RIGHT-OF-WAY ACROSS THE SUBMERGED LANDS OF THE TUOLUMNE RIVER, 150 FEET IN WIDTH AND APPROXIMATELY 133 FEET IN LENGTH, COMPRISING 0.458 ACRE, WHICH EASEMENT SHALL EXTEND NORTHERLY ACROSS THE TUOLUMNE RIVER FROM A POINT NORTH 10° 19' 40" EAST 3,193.76 FEET FROM THE SOUTHWEST CORNER OF SECTION 2, T. 4 S., R. 10 E., M.D.B.& M., STANISLAUS COUNTY. (APPLICATION FOR BRIDGE RIGHT-OF-WAY ACROSS SUBMERGED LANDS OF THE TUOLUMNE RIVER IN SECTION 2, T. 4 S., R. 10 E., M.D.B.& M., STANISLAUS COUNTY - W.O. 3114.)

An application has been received from Stanislaus County for a bridge right-of-way, 150 feet in width, across the submerged lands of the Tuolumne River, which right-of-way will occupy a portion of Section 2, T. 4 S., R. 10 E., M.D.B.& M., the centerline of which extends North  $11^{\circ} 08' 55''$  West 133 feet, more or less, from a point North  $10^{\circ} 19' 40''$  East 3193.76 feet from the southwest corner of said Section 2. The bridge is to serve County Road No. 14 (Geer-Albers Road). No fees or rentals are required.
