## MINUTE ITEM

11. APPLICATION FOR RIGHT-OF-WAY EASEMENT FOR OVERHEAD WIRE CROSSING SUBMERGED LANDS OF MOKELUMNE RIVER,  $\frac{1}{2}$  MILES NORTHWEST OF WOODBRIDGE, SAN JOAQUIN COUNTY, THE PACIFIC GAS AND ELECTRIC COMPANY - W.O. 3130, P.R.C. 2356.1.

After consideration of Calendar Item 11 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE PACIFIC GAS AND ELECTRIC COMPANY A RIGHT-OF-WAY EASEMENT FOR 49 YEARS, 100 FEET IN WIDTH AND APPROXIMATELY 115 FEET IN LENGTH, ACROSS THE SUBMERGED LANDS OF THE MOKELUMNE RIVER IN SECTIONS 7 AND 8, T. 4 N., R. 6 E., M.D.B.& M., SAN JOAQUIN COUNTY, THE INITIAL POINT OF THE CENTERLINE OF SAID EASEMENT BEING SOUTH 46° 50' EAST, 3704.56 FEET FROM THE SOUTH QUARTER CORNER OF SAID SECTION 8, FOR THE CONSTRUCTION AND MAINTENANCE OF AN OVERHEAD TRANSMISSION LINE WITH THE NECESSARY APPURTENANCES. TOTAL RENTAL FOR THE 49-YEAR TERM IS TO BE \$50, WITH NO BOND REQUIRED.

(APPLICATION FOR RIGHT-OF-WAY EASEMENT FOR OVERHEAD WIRE CROSSING SUBMERGED LANDS OF MOKELUMNE RIVER, 42 MILES NORTHWEST OF WOODBRIDGE, SAN JOAQUIN COUNTY, THE PACIFIC GAS AND ELECTRIC COMPANY - W.O. 3130.)

The Pacific Gas and Electric Company has applied for an easement, 100 feet in width and 115 feet, more or less, in length, across submerged lands of the Mokelumne River in Section 7 and 8, T. 4 N., R. 6 E., M.D.B.& M., San Joaquin County, containing 0.265 acre, more or less, to be used for an overhead wire crossing. Since the estimated value of the land to be crossed is less than \$50 per acre, total rental for a term not to exceed 49 years will be \$50 under the policy of the Commission. No performance bond is required. The expense deposit and statutory filing fee have been paid.
