After consideration of Calendar Item 6 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A PERMIT TO SAN DIEGO GAS AND ELECTRIC COMPANY TO EXTEND, BY DREDGING, A CHANNEL 20 FEET BELOW LOW WATER ELEVATION, VARYING IN WIDTH FROM 250 FEET TO 500 FEET AND APPROXIMATELY 3,000 FEET IN LENGTH, IN TIDE AND SUBMERGED LANDS OF SAN DIEGO BAY, BAYWARD OF AND PARALLELING THE U. S. PIERHEAD LINE IN NATIONAL CITY, SAN DIEGO COUNTY, THE SPOILS TO BE DEPOSITED ON TIDE AND SUBMERGED LANDS HELD IN TRUST BY NATIONAL CITY. THE CONSIDERATION FOR THIS AUTHORIZATION IS TO BE THE HENEFIT TO NAVIGATION.

## CALENDAR ITEM

APPLICATION TO DREDGE CHANNEL, TIDE AND SUBMERGED LANDS IN SAN DIEGO COUNTY, SAN DIEGO GAS AND ELECTRIC COMPANY - W.O. 3160.

The San Diego Gas and Electric Company has applied for a permit, pursuant to the provisions of Section 6303 of the Public Resources Code, to extend an existing deep-water channel in San Diego Bay 3,000 feet, more or less, by dredging to a depth of 20 feet below mean low water, in order to create a channel for the navigation of oil barges. The channel would provide access to pipe lines which lead to the applicant's onshore oil storage facilities in National City.

The spoils proposed to be dredged (approximately 135,000 cubic yards) would be deposited on tidelands conveyed by Legislative Grant to National City in 1917. The City of National City, as littoral owner, has consented to the dredging by Crdinance No. 7422, and consent to the depositing of spoils on National City's tidelands has been given by letter dated February 18, 1959.

The District Public Works Officer, U. S. Navy, has approved the dredging of the channel by letter dated February 18, 1959.

The Corps of Engineers, U. S. Army, has informed this Division that it considers the project to be a benefit to navigation.

The expense deposit and the statutory application filing fee have been paid.
