

MINUTE ITEM

8. APPLICATION FOR PERMISSION TO DREDGE, TIDE AND SUBMERGED LANDS, PALO ALTO HARBOR AND ENTRANCE CHANNEL, SANTA CLARA COUNTY AND SAN MATEO COUNTY, CITY OF PALO ALTO - W.O. 3164, P.R.C. 2374.9.

After consideration of Calendar Item 21 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE CITY OF PALO ALTO A PERMIT TO DREDGE APPROXIMATELY 120,000 CUBIC YARDS OF MATERIAL FROM TIDE AND SUBMERGED LANDS LOCATED IN WILSON SLOUGH IN SANTA CLARA COUNTY AND MAYFIELD SLOUGH IN SANTA CLARA AND SAN MATEO COUNTIES, AND TO DEPOSIT THE DREDGED MATERIAL ON APPLICANT'S PROPERTIES, BEHIND THEIR LEVEES. THE STATE LANDS DIVISION IS TO BE NOTIFIED PROMPTLY WHEN THE OPERATION IS COMPLETED. THE CONSIDERATION FOR THE PERMIT IS TO BE THE PUBLIC USE AND BENEFIT TO NAVIGATION.

APPLICATION FOR PERMISSION TO DREDGE TIDE AND SUBMERGED LANDS, PALO ALTO HARBOR AND ENTRANCE CHANNEL, SANTA CLARA COUNTY AND SAN MATEO COUNTY, CITY OF PALO ALTO - W.O. 3164.

An application has been received from the City of Palo Alto to dredge Mayfield and Wilson Sloughs, pursuant to Section 6303 of the Public Resources Code. The proposed dredging is to a depth of eight feet, to serve the applicant's boat harbor, the site for which is in the leased area under P.R.C. 1479.9. The applicant also requests permission to deposit the approximately 120,000 cubic yards of spoil on City-owned land, behind the levees in the immediate vicinity of the project. Wilson Slough is entirely in Santa Clara County, while Mayfield Slough, in its course to San Francisco Bay, traverses a small portion of San Mateo County as well as Santa Clara County. Approval of the dredging project has been received from San Mateo County.

Because the applicant is a political subdivision, no fees are required.
