9. APPLICATION FOR RIGHT-OF-WAY EASEMENT FOR ACCESS ROAD, TIDE AND SUBMERGED LANDS OF HALFMOON BAY, SAN MATEO COUNTY, U. S. ARMY CORPS OF ENGINEERS AND SAN MATEO COUNTY HARBOR DISTRICT - W.O. 3169, P.R.C. 2375.9.

After consideration of Calendar Item 22 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A RIGHT-OF-WAY EASEMENT TO THE U. S. ARMY CORPS OF ENGINEERS AND SAN MATEO COUNTY HARBOR DISTRICT, JOINTLY, FOR THAT PORTION OF AN ACCESS ROADWAY WHICH WILL LIE WITHIN THE TIDE AND SUB-MERGED LANDS OF HALFMOON BAY, SAN MATEO COUNTY, SUCH ROADWAY TO EXTEND DOWN-COAST ALONG THE SHORE LINE FROM PILLAR POINT TO A POINT SOUTH 66° 24' 02° WEST FROM THE NORTHERLY LINE OF THE CENTERLINE OF LOT 19, BLOCK 13, PRIVISION BY THE SEA, HALFMOON BAY, SAN MATEO COUNTY, AS RECORDED IN BOOK 6 OF MACES, PAGE 32, RECORDS; THE ROADWAY IS TO SERVE THE CONSTRUCTION AND MAINTENANCE OF RUBBLE-MOUND BREAKWATERS TO BE CONSTRUCTED AS PROVIDED IN P.R.C. 2353.9, THE CONSIDERATION FOR THE ISSUANCE OF THE EASEMENT IS TO BE THE PUBLIC BENEFIT.

APPLICATION FOR RIGHT-OF-WAY EASEMENT FOR ACCESS ROAD, TIDE AND SUBMERGED LANDS OF HALFMOON BAY, SAN MATEO COUNTY, U. S. ARMY CORPS OF ENGINEERS AND SAN MATEO COUNTY HARBOR DISTRICT - W.O. 3169.

Pursuant to Section 6502, Public Resources Code, an application has been received for a right-of-way easement to be issued jointly to the U. S. Army Corps of Engineers and San Mateo County Harbor District for an access roadway to serve the construction and maintenance of two rubble-mound jettles designed to create a harbor in Halfmoon Bay; the permit for the jettles was approved by the Commission on February 24, 1959. The roadway, consisting of approximately 9.5 acres, will extend downcoast along the shore line from Pillar Point to a point South 66° 24° 02" West 696.98 feet from Lot 19, Block 13, Princeton by the Sea, Halfmoon Bay, as recorded in Book 6 of Maps, page 32, Records of San Mateo County. The area of tide and submerged lands within this roadway area is approximately 7.75 acres. No fees or charges are required for these public agencies.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE A RIGHT-OF-WAY EASEMENT TO THE U.S. ARMY CORPS OF ENGINEERS AND SAN MATEO COUNTY HARBOR DISTRICT, JOINTLY, FOR THAT PORTION OF AN ACCESS HOADWAY WHICH WILL LIE WITHIN THE TIDE AND SUBMERGED LANDS OF HALFMOON BAY, SAN MATEO COUNTY, SUCH ROADWAY TO EXTEND DOWNCOAST ALONG THE SHORE LINE FROM PILLAR POINT TO A POINT SOUTH 66° 24' 02" WEST FROM THE NORTHERLY LINE OF THE CENTERLINE OF LOT 19, BLOCK 13, PRINCETON BY THE SEA, HALFMOON BAY, SAN MATEO COUNTY, AS RECORDED IN BOOK 6 OF MAPS, PAGE 32, RECORDS; THE ROADWAY IS TO SERVE THE CONSTRUCTION AND MAINTENANCE OF TWO RUBBLE-MOUND BREAKWATERS TO BE CONSTRUCTED AS PROVIDED IN P.R.C. 2353.9. THE CONSIDERATION FOR THE ISSUANCE OF THE EASEMENT IS TO BE THE PUBLIC BENEFIT.
