APPLICATION FOR SUBMARINE PIFE LINES RIGHT-OF-WAY OVER TIDE AND SUBMERGED 16. LAND", PACIFIC OCEAN NEAR CARPINTERIA, SANTA BARBARA COUNTY, STANDARD OIL COMPANY OF CALIFORNIA, WESTERN OFERATIONS, INC. - W.O. 3150, P.R.C. 2377.1.

After consideration of Calendar Item 7 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

SULJECT TO THE ISSUANCE OF A U. S. ARMY CORPS OF ENGINEERS PERMIT FOR THIS PROJECT, THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A 49-YEAR RIGHT-OF-WAY EASEMENT TO STANDARD OIL COMPANY OF CALIFORNIA, VISTERN OPERATIONS, INC., FOR THE CONSTRUCTION, MAINTENANCE AND OFERATION OF PIPE LINES EXTENDING FROM THE LINE OF ORDINARY HIGH TIDE AND WITHIN THE FOUNDARIES OF THE TRACT OF LAND DESCRIBED AS FOLLOWS:

APPLICATION FOR SUBMARINE PIPE LINES RIGHT-OF-WAY OVER TIDE AND SUBMERGED LANDS, PACIFIC OCEAN NEAR CARPINTERIA, SANTA BARBARA COUNTY, STANDARD OIL COMPANY OF CALIFORNIA, WESTERN OPERATIONS, INC. - W.O. 3150.

An application has been received from Standard Oil Company of California, Western Operations, Inc., pursuant to Section 6502 of the Public Resources Code, for a right-of-way 100 feet in width and 2750 feet in length, oceanward from the line of ordinary high tide. The centerline of the easement will extend oceanward South 2. 12 West 2550 feet and South 84 42 West 200 feet from a point on the upland tract owned by Clara M. Nichol, described as follows:

All that real property situated in the Carpinteria Valley, Santa Barbara County, State of California, bounded and described as follows:

Beginning at a point on the westerly line of the P. C. Higgins Estate, 50 feet southerly from the center of the right-of-way of the Southern Pacific Railway, marked and designated by a 2" iron pipe, same having a bronze cap marked "P. C. Higgins Estate", and running thence southerly along said line to high water mark of the Pacific Ocean; thence easterly along the meanderings of said Ocean to the southerly line of said P. C. Higgins Estate; thence northerly to a point 50 feet distant from the center of said rightof-way of said railway; thence westerly and parallel to said rightof way, to the place of beginning, containing 16.7 acres, more or less.

The easement is to be used for the construction, maintenance and operation of submarine oil pipe lines, to be placed below the ocean floor, to export oil products.

The upland owner has consented to the contruction and operation of the pipe lines, as required by Section 2002 of the California Administrative Code.

The staff appraisal of the average value of the State lands involved is \$300 per acre. The calculated rental is \$2,475, total for 49 years, payable in advance.

The expense deposit and the statutory application filing fee have been paid. No performance bond is to be required since it is anticipated that the submerged lines will not be removed upon termination except for a small portion adjoining the shore. This portion, according to the terms of the right-of-way easement, will be removed to a depth of 15 feet at mean low tide; or to 150 feet waterward of the line of mean low tide, whichever is the greater.
