8. APPLICATION FOR APPROVAL OF LOCATION OF SUBMERGED TELEPHONE CABLE ACROSS TIDE AND SUBMERGED LANDS OF WHITE SLOUGH, SAN JOAQUIN COUNTY, THE PACIFIC TELEPHONE AND TELEGRAPH COMPANY - W.O. 3183, P.R.C. 2392.9.

After consideration of Calendar Item 29 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO EXECUTE AN APPROVAL OF LOCATION TO THE PACIFIC TELEPHONE AND TELEGRAPH COMPANY FOR A SUBMARINE CABLE CROSSING, IN THE FORM PREVIOUSLY APPROVED BY THE COMMISSION, ACROSS LANDS DESCRIBED AS FOLLOWS, WITH NO RENTAL OR BOND REQUIRED:

A STRIP OF TIDE AND SUBMERGED LAND 50 FEET IN WIDTH, SITUATE IN WHITE SLOUGH, SAN JOAQUIN COUNTY, T. 3 N., R. 5 E., SECTION 30, M.D.B.& M.; THE CENTERLINE OF SAID STRIP BEING DESCRIBED AS FOLLOWS:

BEGINNING AT A PACIFIC GAS AND ELECTRIC COMPANY POWER POLE, FROM WHICH POINT THE CORNER TO SECTIONS 7, 8, 17, AND 18, T. 3 N., R. 5 E., M.D.B.& M., BEARS H. 9° 17' E., 12,781.0 FEET; SAID POINT BEING FURTHER DESCRIBED AS BRING ON TERMINOUS TRACT AT THE INTERSECTION OF THE APPROXIMATE CEMPERIJES OF GORDEN ROAD PROJECTED TO THE NORTHWESTLANY LINE OF CORRETA ROAD; THENCE FROM SAID POINT S. 58° W., 80 FEET MORE OR LESS TO THE ORDINARY HIGH WATER MARK ON THE NORTH BARK OF WHITE SLOUGH AND THE TRUE POINT OF BEGINNING OF THE CENTERLINE DESCRIBED HEREIN; THENCE FROM SAID TRUE POINT OF BEGINNING S. 58° W., 250 FEET MORE OR LISS TO THE ORDINARY HIGH WATER MARK ON THE SOUTH BANK OF WHITE SLOUGH AS SAID LINE EXISTED PRIOR TO THE ARTIFICIAL WIDENING OF THE SLOUGH BY DREDGING FOR LEVEE CONSTRUCTION, AND THE END OF THE CENTERLINE OF THE PARCEL.

An application has been received from The Pacific Telephone and Telegraph Company, pursuant to Section 6502, Public Resources Code, for an approval of location for an easement across the tide and submerged lands of White Slough directly north of the Correla Ferry route for a submarine telephone cable. No rental or performance bond is required. The expense deposit and statutory filing fee have been paid.

A STRIP OF TIDE AND SUBMERGED LAND 50 FEET IN WIDTH, SITUATE IN WHITE SLOUGH, SAN JOAQUIN COUNTY, T. 3 N., R. 5 E., SECTION 30, M.D.B.& M.; THE CENTERLINE OF SAID STRIP BEING DESCRIBED AS FOLLOWS:

BEGINNING AT A PACIFIC GAS AND ELECTRIC COMPANY POWER POLE, FROM WHICH POINT THE CORNER TO SECTIONS 7, 8, 17, AND 18, T. 3 N., R. 5 E., M.D.B.& M., BEARS N. 9° 17' E., 12,781.0 FEET; SAID POINT BEING FURTHER DESCRIBED AS BEING ON TERMINOUS TRACT AT THE INTERSECTION OF THE APPROXIMATE CENTERLINE OF GORDEN ROAD PROJECTED TO THE NORTHWESTERLY LINE OF CORRELA ROAD; THENCE FROM SAID POINT S. 58° W., 80 FEET MORE OR LESS TO THE ORDINARY HIGH WATER MARK ON THE NORTH BANK OF WHITE SLOUGH AND THE TRUE POINT OF BEGINNING OF THE CENTERLINE DESCRIBED HEREIN; THENCE FROM SAID TRUE POINT OF BEGINNING S. 58° W., 250 FEET MORE OR LESS TO THE ORDINARY HIGH WATER MARK ON THE SOUTH BANK OF WHITE SLOUGH AS SAID LINE EXISTED PRIOR TO THE ARTIFICIAL WIDENING OF THE SLOUGH BY DREDGING FOR LEVEE CONSTRUCTION, AND THE END OF THE CENTERLINE OF THE PARCEL.
