10. APPLICATION FOR POWER LINE RIGHT-OF-WAY ACROSS SUBMERGED LANDS, AMERICAN RIVER AT CARMICHAEL, SACRAMENTO COUNTY, SACRAMENTO MUNICIPAL UTILITY DISTRICT - W.O. 3176, P.R.C. 2394.9.

After consideration of Calendar Item 32 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO SACRAMENTO MUNICIPAL UTILITY DISTRICT A 49-YEAR RIGHT-OF-WAY EASEMENT OVER THE AMERICAN RIVER AT CARMICHAEL, DESCRIBED AS FOLLOWS:

WITHIN A STIP OF LAND OF THE UNIFORM WIDTH OF TEN (10) FEET, THE CENTERLINE OF WHICH IS DESCRIBED AS FOLLOWS:

BEGINNING AT THE CORNER COMMON TO LOTS 96, 97 AND 121 AS SHOWN ON THE PLAT OF CAPMICHAEL COLONY, FILED FOR RECORD IN THE OFFICE OF THE RECORDER OF SACRAMENTO COUNTY ON MARCH 11, 1910, IN BOOK 10 OF MAPS, MAR NO. . 9 (SAID POINT OF EXECUTED HISO DETRE THE INTERSPECTION OF THE CENER LINES OF GRANT AVAIUS AND HOLDISTER AVENUE, CARMIGHAEL. The Sacramento Municipal Utility District has applied for a power line right-of-way 10 feet in width and 346 feet, more or less, in length, containing .079 acre, more or less, over the American River at Carmichael, in the SWI of Section 14, T. 9 N., R. 6 E., M.D.B.& M., pursuant to Section 6502 of the Public Resources Code. No fees are to be charged.
