APPLICATION OF THE UNITED STATES DEPARTMENT OF THE INTERIOR TO REMOVE AND USE BORROW MATERIALS FROM UNSOLD STATE SC'OOL LANDS, SECTION 36, T. 18 N., R. 16 E., M.D.B.& M., NEVADA COUNTY - W.O. 3184.

On April 13, 1959, an application was received from the Bureau of Reclamation of the United States Department of the Interior for permission to remove approximately 1,000,000 cubic yards of borrow materials from the $NE_{\rm H}^{\rm L}$ of Section 36, T. 18 N., R. 16 E., M.D.B.& M., required for the proposed construction of Prosser Creek Dam. The Dam will be constructed on Prosser Creek approximately eight miles northeast of Truckee, California, and will consist of an earth-fill structure 139 feet high and 1,850 feet long. The project is for the purpose of flood control on the Truckee River, and also for fish and wild life conservation within the Mountain Home Forest Preserve of the United States Forestry Service.

The materials to be removed consist of approximately one foot of top soil underlain by poorly graded, silty sand and gravel containing boulders up to six feet in diameter. The materials are generally inadequate for processing as sand and gravel aggregate. However, they would be usable in the project in the earth-fill portion of the proposed structure, and would be removed from the land in a manner so as not to impair the usefulness, or mar the appearance of the surface of land, which will be left in a reasonably smooth and even condition.

The subject quarker section of land is included within a pending exchange between the State of California and the Forest Service of the United States Department of Agriculture by which the Forest Service will acquire the property for inclusion within the Mountain Home Forest Preserve. It is estimated that this transaction will be concluded within the next two years. The present value of the property is \$25 to \$35 an acre and the Federal Government's offer to pay for the materials removed at the rate of \$5 an acre is reasonable. Under the contract for this project, which must be let by the Federal Government before the end of June 1959, the approximately 1,000,000 cubic yards of material will be removed within a two-year period.
