An offer has been received from William Clyde Booth and Louise G. Booth of Turlock, California, to purchase the SW_{i}^{1} of SW_{i}^{1} of Section 36, T. 3 S., R. 16 E., M.D.M., containing 40 acres in Mariposa County, at \$20 per acre, the minimum value established by a prior appraisal.
