An offer he been received from Frank P. Donahue of Port Angeles, Washington, to purchase the SE_{π}^{1} of SE_{π}^{1} of Section 13, the SE_{π}^{1} of NE_{π}^{1} and SE_{π}^{1} of NW_{π}^{1} of Section 24, T. 4 N., R. 3 E., and the SE_{π}^{1} of Section 32, T. 6 N., R. 4 E., H.M., containing a total of 160 acres in Humboldt County. This land may be obtained by the State under the indemnity selection procedure. The applicant made an offer of \$800, or \$5 per acre.

By letter dated May 11, 1959, the applicant requested cancellation of the application because he did not wish to pay the costs of appraisal as required by rules and regulations.

The selection of the subject land is considered to be to the advantage of the State in that it will assist the State in satisfying the loss to the School Land Grant and in addition, after sale, will place the land on the tax rolls of the county in which it is situated.

The State's application to relect the land has been accepted by the Bureau of Land Management, and the lands were listed (conveyed) to the State on June 6, 1957.
