7. APPLICATION FOR SEWER OUTFALL EASEMENT, TIDE AND SUBMERGED LANDS, HALF MOON BAY, SAN MATEO COUNTY, HALF MOON BAY SANITARY DISTRICT - W.O. 3257, P.R.C. 2431.9.

After consideration of Calendar Item 2 attached, and upon motion duly male and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO EXECUTE A 49 YEAR EASEMENT TO THE HALF MOON BAY SANITARY DISTRICT FOR A SEWER OUTFALL 20 FEET IN WIDTH AND 1350 FEET IN LENGTH BAYWARD FROM THE LINE OF MEAN HIGH TIDE IN HALF MOON BAY, SAID STRIP BEING DESCRIBED AS FOLLOWS:

A STRIP OF TIDE AND SUBMERGED LAND 20 FEET IN WIDTH SITUATE IN HALF MOON BAY, SAN MATEO COUNTY, LYING 10 FEET ON EITHER SIDE OF THE FOLLOWING DESCRIBED CENTERLINE:

BEGINNING AT A POINT ON THE MEAN HIGH TIDE LINE OF HALF MOON BAY WHICH BEARS S. 84° 32' 30" W. 250 FEET; S. 88° 09' 32" W., 419.32 FIET; ALONG PILARCITAS CREEK N. 53° W. 376.00 FEET; S. 55° 15' W. 1980.00 FEET; AND ALONG THE WESTERLY LINE OF STATE HIGHWAY NO. 1 S. 40° 15' W., 1058.64 FEET FROM THE NORTH-WESTERLY CORNER OF THE LANDS OF JOSEPH DEBENEDETTI, AS SAID LANDS ARE DESCRIBED IN A DEED RECORDED IN VOLUME 94, PAGE 430, DATED DECEMBER 1, 1902, OFFICIAL RECORDS OF THE COUNTY OF SAN MATEO; THENCE FROM SAID POINT OF BEGINNING S. 84° 32' 30" W., 1350 FEET, CONTAINING 0.620 ACRES.

APPLICATION FOR SEWER OUTFALL EASEMENT, TIDE AND SUBMERGED LANDS, HALF MOON BAY, SAN MATEO COUNTY, HALF MOON BAY SANITARY DISTRICT - W.O. 3257.

An application has been received from Half Moon Bay Sanitary Nistrict, pursuant to Section 6502 of the Public Resources Code, for an easement 20 feet in width and 1350 feet in length to contain a sewer outfall line in tide and submerged lands of Half Moon Bay near Pilarcitas Creek, San Mateo County. The Regional Water Pollution Control Board approved this project by letter dated April 6, 1959. No fees or charges are to be paid.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO EXECUTE A 49-YEAR EASEMENT TO THE HALF MOON BAY SANITARY DISTRICT FOR A SEWER OUTFALL 20 FEET IN WIDTH AND 1350 FEET IN LENGTH BAYWARD FROM THE LINE OF MEAN HIGH TIDE IN HALF MOON BAY, SAID STRIP BEING DESCRIBED AS FOLLOWS:
