

MINUTE ITEM

12. APPLICATION FOR DREDGING PERMIT, CARQUINEZ STRAIT, CONTRA COSTA COUNTY, CHANDLER LLOYD, TRUSTEE - W.O. 3290, P.R.C. 2440.9.

After consideration of Calendar Item 40 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A PERMIT TO CHANDLER LLOYD, TRUSTEE, AUTHORIZING THE DREDGING OF APPROXIMATELY 79,000 CUBIC YARDS OF MATERIAL FROM LANDS INCLUDED IN TIDE AND SUBMERGED LAND LEASE P.R.C. 2408.1 AT OZOL, CONTRA COSTA COUNTY, WITHOUT ANY PAYMENT OF ROYALTY. THE DREDGED MATERIAL IS TO BE DEPOSITED ON TIDE AND SUBMERGED LANDS GRANTED TO THE CITY OF MARTINEZ AND ON MARSH LANDS OWNED BY THE CITY. THE ISSUANCE OF THE PERMIT IS SUBJECT TO THE ISSUANCE OF A PERMIT BY THE U. S. ARMY CORPS OF ENGINEERS FOR THE SAME OPERATION.

APPLICATION FOR DREDGING PERMIT, CARQUINEZ STRAIT, CONTRA COSTA COUNTY,
CHANDLER LLOYD, TRUSTEE - W.O. 3290.

An application has been received from Chandler Lloyd, Trustee, of Dallas, Texas, lessee under tide and submerged land Lease P.R.C. 2408.1 at Ozol, Carquinez Strait, Contra Costa County, for a permit to dredge 79,000 cubic yards of spoil material from the area included within the lease, for the purpose of deepening berths and channels for vessels.

The dredged material will be deposited on tidelands granted to the City of Martinez under the Statutes of 1929, and on marsh lands owned by the City. The deposit of dredged material on City lands has been authorized by the City Council.

The applicant, Chandler Lloyd, Trustee, has applied to the Corps of Engineers for a Department of the Army permit covering proposed dredging operations. Section 6303 of the Public Resources Code states, in part; "When a contractor or a permittee has a contract with or a permit from the Federal Government... to dredge navigable streams for the improvement of navigation, the commission may, when in the best interests of the State, allow such contractor or permittee to have sand, gravel, or other spoils dredged from the sovereign lands of the State located within the areas specified in such contract or permit without paying a royalty therefor. The amounts of sand, gravel, or other spoils so removed from sovereign lands shall not exceed those specified in the contract or permit."

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE A PERMIT TO CHANDLER LLOYD, TRUSTEE, AUTHORIZING THE DREDGING OF APPROXIMATELY 79,000 CUBIC YARDS OF MATERIAL FROM LANDS INCLUDED IN TIDE AND SUBMERGED LAND LEASE P.R.C. 2408.1 AT OZOL, CONTRA COSTA COUNTY, WITHOUT ANY PAYMENT OF ROYALTY.
