

MINUTE ITEM

16. APPLICATION FOR SEWER LINE CROSSING, TIDE AND SUBMERGED LANDS OF MORMON SLOUGH IN STOCKTON, SAN JOAQUIN COUNTY, CITY OF STOCKTON - W.O. 3267, P.R.C. 2432.9.

After consideration of Calendar Item 10 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO EXECUTE A 49-YEAR EASEMENT TO THE CITY OF STOCKTON FOR A SEWER LINE CROSSING TIDE AND SUBMERGED LANDS OF MORMON SLOUGH, 16 FEET IN WIDTH AND APPROXIMATELY 156 FEET IN LENGTH, SAID STRIP BEING DESCRIBED AS FOLLOWS:

A STRIP OF LAND 16 FEET IN WIDTH SITUATE IN MORMON SLOUGH AND LYING 8 FEET ON EITHER SIDE OF THE FOLLOWING DESCRIBED CENTERLINE:

BEGINNING AT A POINT ON THE ORDINARY HIGH WATER MARK OF THE LEFT BANK OF THE MORMON SLOUGH WHICH BEARS N. $51^{\circ} 36'$ E., 60 FEET; N. $65^{\circ} 27'$ E., 585.24 FEET; AND N. $29^{\circ} 54'$ E., 110.0 FEET FROM THE POINT OF INTERSECTION OF THE CENTERLINE OF LOS ANGELES AVENUE WITH THE NORTHERLY LINE OF HARBOR STREET IN THE CITY OF STOCKTON; THENCE FROM SAID POINT OF BEGINNING N. $51^{\circ} 36'$ E., 156 FEET MORE OR LESS TO THE ORDINARY HIGH WATER MARK OF THE RIGHT BANK OF THE MORMON SLOUGH, CONTAINING .06 ACRE.

APPLICATION FOR SEWER LINE CROSSING, TIDE AND SUBMERGED LANDS OF MORMON SLOUGH IN STOCKTON, SAN JOAQUIN COUNTY, CITY OF STOCKTON - W.O. 3267.

An application has been received from the City of Stockton, pursuant to Section 6502 of the Public Resources Code, for an easement 16 feet in width and approximately 156 feet in length to contain a sewer line crossing Mormon Slough in the City of Stockton.

No fees or charges are to be paid.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO EXECUTE A 49-YEAR EASEMENT TO THE CITY OF STOCKTON FOR A SEWER LINE CROSSING TIDE AND SUBMERGED LANDS OF MORMON SLOUGH, 16 FEET IN WIDTH AND APPROXIMATELY 156 FEET IN LENGTH, SAID STRIP BEING DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE ORDINARY HIGH WATER MARK OF THE LEFT BANK OF THE MORMON SLOUGH WHICH BEARS N. 51° 36' E., 60 FEET; N. 65° 27' E., 585.24 FEET; AND N. 29° 54' E., 110.0 FEET FROM THE POINT OF INTERSECTION OF THE CENTERLINE OF LOS ANGELES AVENUE WITH THE NORTHERLY LINE OF HARBOR STREET IN THE CITY OF STOCKTON; THENCE FROM SAID POINT OF BEGINNING N. 51° 36' E., 156 FEET MORE OR LESS TO THE ORDINARY HIGH WATER MARK OF THE RIGHT BANK OF THE MORMON SLOUGH, CONTAINING .06 ACRE.
