An application has been received from Edith C. Knight of Yuma, Arizona, for a grazing lease for a term of five years on Section 16, T. 4 N., R. 23 E.; $N_{\frac{1}{2}}$, $SW_{\frac{1}{4}}$, $W_{\frac{1}{2}}$ of $SE_{\frac{1}{4}}$, and $SE_{\frac{1}{4}}$ of Section 16, T. 4 N., R. 24 E.; Section 16, T. 5 N., R. 22 E.; Section 36, T. 5 N., R. 23 E.; Section 16, T. 6 N., R. 21 E.; $W_{\frac{1}{2}}$, $SE_{\frac{1}{4}}$, $W_{\frac{1}{2}}$ of $NE_{\frac{1}{4}}$ of $NE_{\frac{1}{4}}$ of Section 16, T. 7 N., R. 21 E.; and Section 16, T. 8 N., R. 20 E., S.B.M., containing 4,400 acres in San Bernardino County.

An appraisal by a member of the Commission's staff on April 21, 1959, indicates the fair grazing rental value to be \$0.015 per acre per year, or a total of \$66.

The \$5 filing fee, \$100 deposit for appraisal, and \$132 for the first and fifth years' rental, at the rate of \$66 per year, have been submitted.
