APPLICATION FOR RIGHT-OF-WAY EASEMENT FOR OVERHEAD WIRE CROSSING, SUBMERGED LANDS OF THE MOKELUMNE RIVER AT WOODBRIDGE, SAN JOAQUIN COUNTY, PACIFIC GAS AND ELECTRIC COMPANY - W.O. 3276.

An application has been received from the Pacific Gas and Electric Company, pursuant to Section 6502 of the Public Resources Code, for an easement over 0.346 acres of land for overhead wires crossing the Mokelumne River at Woodbridge, San Joaquin County.

The estimated value of the land to be crossed is less than \$50 per acre; therefore, the <u>calculated</u> total rental for a term not to exceed 49 years is \$50. No performance bond is required. The expense deposit and statutory filing fee have been paid.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO THE PACIFIC GAS AND ELECTRIC COMPANY A RIGHT-OF-WAY EASEMENT FOR 49 YEARS OVER THE FOLLOWING DESCRIBED PARCEL OF SUBMERGED LANDS IN SAN JOAQUIN COUNTY:
