CANCELLATION OF LOG STORAGE IEASE, P.R.C. 641.1, DEL MORIE COUNTY, KLAMATH CEDAR COMPANY - W.O. 3145.

A 15-year lease for log storage in Del Norte County was issued to Klamath Cedar Company, effective August 29, 1951.

Section 3 of said Lease P.R.C. 641.1 provides that the lessee shall pay rentals, without deduction, default or delay; and in the event of failure of the lessee to do so, it shall be lawful for the State to re-enter into and upon the demised premises, and to repossess and enjoy the premises as in the first and former estate of the State.

The lessee has failed to pay the $\$ 50$ annuai rental due August 29, 1958, despite notification on Augtist 1, 1958, September 22, 1958, and finai notification by certifiea mail December 2, 1958, that the lease was in default and subject to cancellation. On July 31, 1959, the lessee was notified that the lease is to be canceled and to remove structures, etc., from the leased premises within 90 days from date thereor, as provided in Paragraph 14 of said lease.

IT IS RECOMMENDED THAT THE COMMISSION AUIHORIZE THE EXECUITVE OFFICER:
(1) TO CANCEL IEASE P.R.C. 641.1, DEL NORTE COUNTY, AS OF AUGUST 28, 1959, dUe TO FAILURE OF The LESSEE, KLAMATH CEDAP COMPANY, TO PAY THE EIGETH ANNUAL RENTAL;
(2) TO APPLY THE IAST YEAR'S RENTAL, PAID IN ADVANCE, IN SAMISFACTION OF THE ATOREMENTIONED EIGHTH AMNUL RENTAL.
