After consideration of Calendar Item 21 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO JOHN A. FITZGERALD A TWO-YEAR RENEWAL OF LEASE P.R.C. 595.1, EFFECTIVE SEPTEMBER 30, 1959, AT A TOTAL RENTAL OF \$200, COVERING THOSE CERTAIN LANDS IN MIDDLE RIVER RETWEEN THE ORDINARY JIGH WATER MARK ON THE RIGHT SIDE OF MIDDLE RIVER AND A LINE PARALLEL TO AND 50 FEET DISTANT FROM THE SAID ORDINARY JH WATER MARK AND EXTENDING 330 FEET DOWNSTREAM FROM THE BORDEN HIGHWAY RICHT-OF-WAY, SAID RIGHT-OF-WAY BEING 340 FEET IN WIDTH.

APPLICATION FOR RENEWAL OF LEASE P.R.C. 595.1, MIDDLE RIVER, SAN JOAQUIN COUNTY, JOHN A. FITZGERALD - W.O. 3324.

John A. Fitzgerald is the present lessee of a small parcel of tide and submerged lands in Middle River, adjacent to Borden Highway Bridge, San Joaquin County. Mr. Fitzgerald has applied for a renewal of two years commencing September 30, 1959 and has deposited \$200, being the total established rental for that period.

By letter dated April 24, 1957, the attorneys for the owners of the upland advised that they have no objections to continuance of the lease. The surety bond is still in effect.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO ISSUE TO JOHN A.
