APPLICATION TO APPROVE SUBLEASE P.R.C. 2364.2, SECTION 36, T. 1 N., R. 1 W., M.D.M., CONTRA COSTA COUNTY, LINDSEY SPIGHT - W.O. 3341.

Lease P.R.C. 2364.2 was issued to Lindsey Spight for 15 years, beginning March 16, 1959, with two renewal periods of 10 years each, covering Lot 4 and W_2^1 of Lot 2, Section 36, T. 1 N., R. 1 W., M.D.M. An application has been received from Lindsey Spight, d.b.a. Diablo Communications Center, pursuant to the terms of said lease, for approval of a sublease dated September 10, 1959, to Ligge Drayage Company for a portion of the leased site sufficient to operate a VHF Motor Carrier Service 960 Megacyles Controlled 40 Megacycle Base Station. The sublease is to run for an indefinite period, not to extend beyond the tenure of Lease P.R.C. 2364.2.
