6. QUITCLAIM OF MINERAL PROSPECTING PERMIT P.R.C. 2279.1, G. R. ARMANN AND WENDELL MENNPAGE, MONTEREY COUNTY - W.O. 3379.

After presentation of Calendar Item 4 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ACCEPT THE QUITCLAIM AND TERMINATION OF MINERAL PROSPECTING PERMIT P.R.C. 2279.1, COVERING THE FOLLOWING DESCRIBED SUBMERGED LAND:

THAT AREA OF SUBMERGED LANDS BOUNDED ON THE SOUTH BY CALIFORNIA COORDINATE SYSTEM, ZONE 4, GRID LINE HAVING A Y VALUE OF 223,000; ON THE NORTH BY A GRID LINE HAVING A Y VALUE OF 224,270; ON THE LANDWARD (EASTERLY) BOUNDARY BY THE ORDINARY LOW WATER MARK OF THE PACIFIC OCEAN; ON THE WESTERLY (SEAWARD) SIDE BY A NORTH-SOUTH LINE THROUGH A POINT ON THE SOUTH BOUNDARY, ONE-QUARTER STATUTE MILE WEST OF THE INTERSECTION OF THE ORDINARY LOW WATER MARK WITH THE SOUTH POUNDARY OF THE PERMIT AREA IN T. 23 S., R. 4 AND 5 E., M.D.B.& M., MONTEREY COUNTY, CONTAINING 80 ACRES, MORE OR LESS.

THE QUITCLAIM IS TO BE EFFECTIVE NOVEMBER 5, 1959, AS REQUESTED BY THE PERMITTEES, G. R. ARMANN AND WENDELL RENNPAGE.

QUITCLAIM OF MINERAL PROSPECTING PERMIT P.R.C. 2279.1, G. R. ARMANN AND WENDELL RENNPAGE, MONTEREY COUNTY - W.O. 3379.

Prospecting Permit P.R.C. 2279.1, covering app oximately 80 acres of submerged land in T. 23 S., R. 4 E., and T. 23 S., R. 5 E., M.D.B.& M., Monterey County, was issued to G. R. Armann and Wendell Rennpage on December 3, 1958, pursuant to Section 6891 of the Public Resources Code, for a period of two years, to prospect for minerals other than oil and gas.

The permittees recovered one jade boulder (nephrite) from the ocean floor in the permit area. This material is a silicate of calcium, magnesium and iron. The demand for the material is dependent upon the quality. The permittees have reported that after an exhaustive search no market for this type of jade has been found and none of the material has been sold. The permittees have submitted a quitclaim to the permit area, dated November 7, 1959.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ACCEPT THE QUITCLAIM AND TERMINATION OF MINERAL PROSPECTING PERMIT P.R.C. 2279.1, COVERING THE FOLLOWING DESCRIBED SUBMERGED LAND:
