

MINUTE ITEM

11. QUITCLAIMS OF MINERAL PROSPECTING PERMITS, PATRICK J. O'HORNETT, KERN COUNTY - W.O. 3385.

After presentation of Calendar Item 28 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ACCEPT THE QUITCLAIM AND TERMINATION OF PROSPECTING PERMITS COVERING APPROXIMATELY 5,376 ACRES OF LAND IN KERN COUNTY IN WHICH THE MINERALS ARE RESERVED TO THE STATE, MORE PARTICULARLY DESCRIBED IN EXHIBIT "A" ATTACHED HERETO AND HEREBY MADE A PART HEREOF. THE QUITCLAIM IS TO BE EFFECTIVE NOVEMBER 16, 1959, AS REQUESTED BY THE PERMITTEE, PATRICK J. O'HORNETT.

QUITCLAIMS OF MINERAL PROSPECTING PERMITS, PATRICK J. O'HORNETT, KERN COUNTY - W.O. 3385.

Thirty-four prospecting permits, more fully described in Exhibit "A" attached, covering approximately 5,376 acres of land in Kern County in which the minerals were reserved to the State were issued to Patrick J. O'Hornett, pursuant to Section 6891 of the Public Resources Code for a period of two years to prospect for all mineral-bearing ores and solutions containing sulphates, carbonates, borates, silicates, nitrates or chlorides.

In addition to State lands, the permittee has leased other areas in the general vicinity. Geological and geophysical surveys have been conducted, and no commercially valuable deposits of the minerals sought have been discovered. No minerals have been extracted or shipped from the permit areas, and no royalty payments are due the State. The permittee has submitted a quitclaim deed, dated November 16, 1959, to the permit areas in Kern County.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ACCEPT THE QUITCLAIM AND TERMINATION OF PROSPECTING PERMITS COVERING APPROXIMATELY 5,376 ACRES OF LAND IN KERN COUNTY IN WHICH THE MINERALS ARE RESERVED TO THE STATE, MORE PARTICULARLY DESCRIBED IN EXHIBIT "A" ATTACHED HERETO AND HEREBY MADE A PART HEREOF. THE QUITCLAIM IS TO BE EFFECTIVE NOVEMBER 16, 1959, AS REQUESTED BY THE PERMITTEE, PATRICK J. O'HORNETT.
